## INTRODUCED BY COUNCILMEMBER HENRY CHANG, JR.

RESOLUTION AUTHORIZING A GRANT OF \$1500 FROM COUNCILMEMBER HENRY CHANG'S PAY-GO FUNDS TO THE OAKLAND, CALIFORNIA BABE RUTH LEAGUE FOR EXPENSES ASSOCIATED WITH TWO MEMBERS OF THE ALL STAR TEAM PARTICIPATING IN THE 2008 COLLEGE TOUR

**WHEREAS,** on July 17, 2007, the City Council revised the Pay-Go procedures and Pay-go grants to include allocation of funds for community service programs operated by non-profits in the City of Oakland such as the Oakland, California Babe Ruth League subject to City Council approval; and

WHEREAS, the Oakland, California Babe Ruth League, a 501(c)3 organization, targets 14 and 15 year old at-risk youth from throughout Oakland, and provides them with a quality athletic program that stresses the importance of a college education and community service; and

WHEREAS, The Oakland California Babe Ruth League's All Star Team will make a campus tour of Morehouse College and Florida A & M University in the Fall of 2008 to become familiar with the academic, athletic, and social aspects of these institutions of higher education; and to participate in the Disney Wide World of Sports Tournament in Orlando Florida; now therefore, be it

**RESOLVED:** that the City Council authorizes a grant of \$1,500 from Councilmember Henry Chang's Pay-Go funds to the Oakland, California Babe Ruth League to be used for expenses associated with two members of the All Star Team participating in the Fall 2008 College Tour; and, be it

**FURTHER RESOLVED**: that the City Administrator is authorized to execute an appropriate grant agreement with Oakland, California Babe Ruth League Team consistent with the purposes of the grant, subject to approval as to form and legality by the City Attorney.
