RESOLUTION 1) AUTHORIZING THE CITY ADMINISTRATOR TO APPLY FOR AND ACCEPT THE U.S. DEPARTMENT OF AGRICULTURE CHILD AND ADULT CARE FOOD PROGRAM (CACFP) GRANT FROM THE CALIFORNIA DEPARTMENT OF EDUCATION IN AN ESTIMATED AMOUNT OF \$243,632 TO PROVIDE FUNDING FOR NUTRITIOUS MEALS FOR THE HEAD START/EARLY HEAD START PROGRAM FROM JULY 1, 2018 THROUGH JUNE 30, 2019; AND 2) AUTHORIZING A GENERAL PURPOSE FUND CONTRIBUTION IN THE AMOUNT EQUIVALENT TO CENTRAL SERVICE OVERHEAD COSTS ESTIMATED AT \$41,675

WHEREAS, the City of Oakland desires to apply for and accept a US Department of Agriculture/Child and Adult Care Food Program (USDA/CACFP) Grant in an estimated amount of \$243,632 from the California Department of Education (“CDE”) to fund a Head Start/Early Head Start child nutrition program from July 1, 2018 through June 30, 2019; and

WHEREAS, the City’s Fiscal Year (FY) 2018-2019 Midcycle Proposed Budget includes \$243,632 in appropriations and revenues for FY 2018-2019 for the CACFP grant; and

WHEREAS, staff is requesting a contribution from the General Purpose Fund equivalent to the central service overhead costs associated with this grant in the estimated amount of \$41,675 due to administrative cost limitations; and

WHEREAS, the CDE Child Nutrition and Distribution Division will provide funds for comprehensive nutrition services to approximately 300 Head Start and Early Head Start children, who have the most economic need, with ten percent of the enrollment consisting of children with special needs; now, therefore, be it

RESOLVED: That the City Administrator or her designee is hereby authorized to submit an application to the CDE for USDA/CACFP funds to operate a Child Care Food Program for children enrolled in the Oakland Head Start and Early Head Start program from July 1, 2018 through June 30, 2019, and to accept said funds in an estimated amount of \$243,632; and be it

FURTHER RESOLVED: That the City Administrator is hereby authorized to accept and appropriate any additional funding which may become available from this grantor, for the same purposes, within the existing grant term, July 1, 2018 to June 30, 2019, without returning to Council; and be it

FURTHER RESOLVED: That the estimated sum of \$243,632 and offsetting revenue is included in the FY2018/19 Midcycle Proposed Budget and appropriated in the Department of Agriculture Fund (2102), HS Classroom and Seasonal Org (78231), Head Start FY18-19 CCFP Project (1004056), Strengthening Children, Youth & Families Program (YS13) for the purpose of operating the Head Start child care food program; and be it

FURTHER RESOLVED: That all central services overhead charges associated with this grant in an estimated amount of \$41,675 will be offset through a contribution of the General Purpose Fund.


