Resolution Authorizing The City Administrator, Or Her Designee, To 1) Award A Construction Manager At Risk Contract To Turner Construction Company For An Amount Not To Exceed Eleven Million Nine Hundred Thousand Dollars (\$11,900,000.00) For The East Oakland Sports Center Project; And 2)

Appropriate \$8,415,000.00 Of Measure DD Series B Funds In The Oakland

**Sports Center Project (C244610)** 

### **SUMMARY**

A resolution has been prepared authorizing the City Administrator, or her designee, to award a Construction Manager At Risk (CMAR) contract for the East Oakland Sports Center project for an amount not to exceed \$11,900,000.00, to Turner Construction Company, an Oakland-based business. The East Oakland Sports Center project consists of a 22,500 square foot building, which includes an indoor recreational swimming pool (natatorium), changing rooms, rest rooms, reception area with offices, an aerobics/dance room, a multi-purpose room/learning center and a parking lot. If funding is available, a fitness center will be added to the project scope.

The use of a CMAR contract for this project allows the City to utilize the contractor's expertise during the design phrase and to expedite the contracting process so that the project construction can begin before January 2009. The construction of East Oakland Sports Center project must be expedited to complete the project by March 2010 in order to meet the grant deadline for a \$2,400,000.00 Proposition 40 state grant.

The scope of services for the CMAR is divided into two tasks. The first task will involve preconstruction services, which in general, includes providing value engineering and constructibility reviews for the project, advice on phasing construction and cost estimating. The second task, in general, involves acting as the general contractor for the City, soliciting competitive bids and selecting sub-contractors, administering subcontractor contracts, scheduling and coordinating of the construction work, and delivery of a completed project. Turner Construction Company will be required to meet the all City Local Business Enterprise Programs (LBE/SLBE) and apprenticeship programs for the entire project.

Turner Construction Company was selected to provide CMAR services for the East Oakland Sports Center project through a formal proposal and interview process. They are highly qualified

and have extensive experience with large public works projects and have successfully completed more than 100 CMAR projects. Their local work includes projects at the Oakland Airport, Oakland Children's Hospital, and Fox Theater, Oakland.

Approval of this resolution will authorize and direct the City Administrator to appropriate \$8,415,000.00 in Measure DD Series B, the Oakland Trust for Clean Water and Safe Parks Fund (5320), East Oakland Sports Center Project (C244610) in anticipation that additional Series B Funds will become available in the 2008/2009 fiscal year. There is a sufficient cash fund balance available in Measure DD Series A to pay for this work until the Series B Bonds are issued.

#### FISCAL IMPACT

Approval of this resolution will authorize a CMAR contract in an amount not to exceed \$11,900,000.00 for the East Oakland Sports Center project with Turner Construction Company.

Upon approval of this resolution, funds in the amount of \$11,900,000.00 will be available from the following sources:

- \$2,400,000.00 from State Proposition 40, 2002 Resources Bond Act (Fund 2134, East Oakland Sports Center, Project No. C268010, Capital Project Management Organization 92270)
- \$1,085,000.00 from Measure I, Oakland General Obligation Bonds for Parks (Fund 5010, East Oakland Sports Center, Project No. C83213, Capital Project Management Organization 92270)
- \$8,415,000.00 from Measure DD the Oakland Trust for Clean Water and Safe Parks (Fund 5320, East Oakland Sports Center Project No. C244610, Capital Project Management Organization 92270). Approval of this resolution will authorize and direct the City Administrator to appropriate \$8,415,000.00 from the fund balance (Measure DD Series A).

Approval of this resolution will authorize and direct the City Administrator to appropriate \$8,415,000.00 in Measure DD Series B, the Oakland Trust for Clean Water and Safe Parks Fund (5320), East Oakland Sports Center Project (C244610) in anticipation that additional Series B Funds will become available in the 2008/2009 fiscal year. There is a sufficient cash fund balance available in Measure DD Series A to pay for this work until the Series B Bonds are issued.

It is anticipated that the City's annual building operation and maintenance costs for the East Oakland Sports Center will be approximately \$340,000.00. All operation and maintenance costs will be included in the 2009-2011 PWA facilities budget request.

Item: \_\_\_\_\_ CEDA Committee June 24, 2008 The project has been approached with the intent to offset a substantial amount of the operating costs with user fees. An initial study by the Sports Management Group indicates that the potential average cost recovery from users would be about 70%.

### **BACKGROUND**

The concept for the East Oakland Sports Center originated prior to 1996 with visions to create a recreation complex with aquatics, fitness centers, gymnasiums, and other sports facilities that would serve the local community and be used as a venue for the possible 2012 San Francisco Bay Area Olympic Games. Although the San Francisco Bay Area was not chosen for the 2012 Olympic Games, the need for a sports complex with an aquatics component is still a high priority. Current available funding will allow this project to go forward and take advantage of the State Proposition 40 grant funding.

The East Oakland Sports Center will be constructed on Edes Avenue between Jones Avenue and Phelps Street at Ira Jinkins Park. The East Oakland Sports Center Phase 1 project includes a total of 22,500 square feet of building floor space. The building includes an indoor recreational swimming pool (natatorium), changing rooms, rest rooms, reception area with offices, an aerobics/dance room, a multi-purpose room/learning center and a parking lot. If funding is available, a fitness center will be added to the project scope.

The East Oakland Sports Center project was included in the Environmental Impact Report for the City of Oakland Bond Measure DD projects. This EIR was certified April 1, 2008. This project is in compliance with the EIR.

A Major Conditional Use Permit (MCUP) was approved for the project on April 4, 2008. The MCUP approved the currently proposed project as well as the Master Plan. The Master Plan would add the following to the currently proposed project when future funding becomes available: a two-court basketball gymnasium with an elevated indoor running track, an outdoor competitive swimming pool, two new baseball/softball fields, three new soccer fields, 119 additional parking spaces, and new parking access. The existing 15,500 square foot recreation center and the adjacent 71-space parking lot would be removed under the full Master Plan build-out scenario.

The construction of the East Oakland Sports Center is being expedited by using the CMAR method in order to complete the project by March 2010 so that the City will qualify for reimbursement for the State Urban Park Act of 2001 (Proposition 40) grant of \$2.4 million. The CMAR method is also most beneficial for projects of this nature.

Under the CMAR method, the CMAR works collaboratively with the City and the Architect's design team during the design phase to provide value engineering, constructibility reviews,

advice on phasing, and cost estimating. Upon completion of design, the contractor is required to competitively bid out the construction work for the project to subcontractors on a per-trade basis. The final contract price is the sum of the subcontractor costs, the CMAR's markup and overhead, fee for service, and CMAR construction costs, if any. The CMAR will not be self-performing any major construction work for the project as their main responsibility is to coordinate and schedule all construction work and to deliver the completed project.

### **KEY ISSUES AND IMPACTS**

In November 2007, the City of Oakland issued a Request for Qualifications/Proposals for Construction Management At Risk Services for the East Oakland Sports Center project. Five proposals were received. The proposal review panel consisted of a member of the City of Oakland Parks and Recreation Advisory Commission (PRAC), a project manager with the Port of Oakland, a Supervising Civil Engineer with the City of Oakland, a construction manager with the City of Oakland, and a Capital Improvement Project Coordinator with the City of Oakland.

The panelists evaluated and ranked five proposals based on the quality and content of the proposals. Attachment A of this report is the Proposal Score Sheet Summary. The rankings of the proposals were established based on the average score of each firm. Additionally, the ordinal ranking (which provides the relative order of each firm's position in comparison to each firm) was reviewed and was shown to correlate with the scoring ranking. In determining the cut-off point for which firms were to be selected for interviews, the gap between the fourth and fifth ranked firms was distinctive.

The four short-listed firms were then interviewed and evaluated by the five panelists. The evaluation criteria for the interview included:

- 1. Relevant experience and strengths of the firm;
- 2. Organization of firm, availability of resources and capability to meet project schedules;
- 3. Qualifications of project team and project manager; and
- 4. Meaningful responses to interview questions.

Attachment B is the Interview Score Sheet Summary. Turner Construction Company was the top ranked firm and they have the technical expertise to perform the work required, and clearly demonstrated their understanding of the complexities and regulatory issues involved in the design and construction of the East Oakland Sports Center. Turner Construction Company has successfully completed more than 100 CMAR projects and their local work includes projects at the Oakland Airport, Oakland Children's Hospital, and Fox Theater, Oakland.

Turner Construction Company achieved 90% local and 10% small local business participation, which met the 20% L/SBLE requirements for the pre-construction services. The L/SLBE information has been verified by the Department of Contracting and Purchasing and is included

as Attachment C, Contract Compliance Memo. Turner Construction Company will be required to meet the City's Local Business Enterprise Programs (LBE/SLBE) for the entire project. There will be additional opportunities for L/SLBE participation in the construction phase as the CMAR will be required to meet all of the LBE/SLBE programs. Turner Construction Company will maximize local business participation by performing extensive outreach services to local contractors and trade associations, by structuring trade packages accordingly, assisting and encouraging non-certified local firms to become certified, and providing references in obtaining bonds and insurance.

### PROJECT DESCRIPTION

The East Oakland Sports Center project will be constructed on Edes Avenue between Jones Avenue and Phelps Street at Ira Jinkins Park. The project will include a total of 22,500 square feet of building floor space; 6,000 square feet on the upper level and 16,500 square feet at ground level. The building includes a 9,000 square foot indoor swimming pool building (natatorium) with a 3,500 square foot indoor recreational swimming pool, changing rooms and rest rooms, a reception area with meeting rooms and offices, an aerobics/dance room, and a multi-purpose room/learning center. An 85-space parking lot will also be included. If funding is available, a 3,800 square foot fitness center will be added to the project scope.

#### SUSTAINABLE OPPORTUNITIES

**Economic:** The project will generate business tax, sales tax, and other revenues for the City by those firms who work on the project.

**Environmental:** Environmental factors and opportunities will be considered and incorporated to the extent feasible. The consultants and contractor will be required to achieve a LEED silver rating in the design and construction of the facility by maximizing recycled content materials in the products, waste reduction, energy conservation, and integrating other environmental opportunities. The water for the recreational swimming pool will be heated by solar thermal panels mounted on the roof of the natatorium.

**Social Equity:** The East Oakland Sports Center will provide new social opportunities and services to the community with much needed aquatic and recreational facilities for all ages and abilities and will provide a venue for building community cohesiveness and community pride.

### DISABILITY AND SENIOR CITIZEN ACCESS

The East Oakland Sports Center will be in full compliance with the physical access requirements of the American with Disabilities Act ("ADA") by providing equal access to the facility.

### RECOMMENDATION AND RATIONALE

Staff recommends that the Council approve the resolution.

RESOLUTION AUTHORIZING THE CITY ADMINISTRATOR, OR HER DESIGNEE TO, 1) AWARD A CONSTRUCTION MANAGER AT RISK CONTRACT TO TURNER CONSTRUCTION COMPANY FOR AN AMOUNT NOT TO EXCEED ELEVEN MILLION NINE HUNDRED THOUSAND DOLLARS (\$11,900,000.00) FOR THE EAST OAKLAND SPORTS CENTER PROJECT; AND 2) APPROPRIATE \$8,415,000.00 OF MEASURE DD SERIES B FUNDS IN THE OAKLAND SPORTS CENTER PROJECT (C244610)

WHEREAS, the East Oakland Sports Center is a much needed project to provide the community with a variety of year-round recreational opportunities; and

WHEREAS, East Oakland Sports Center Project was included in the Environmental Impact Report for the City of Oakland Bond Measure DD projects, which was certified April 1, 2008, and no additional supplemental environmental clearance is required; and

WHEREAS, the East Oakland Sport Center is being expedited for completion in March 2010 in order to qualify for \$2,400,000.00 in State Urban Park Act of 2001 (Proposition 40) funding; and

WHEREAS, in November 2007, the City of Oakland issued a Request for Qualifications/Proposals for Construction Manager At Risk (CMAR) services for the East Oakland Sports Center project; and

WHEREAS, the top ranked firm was Turner Construction Company, an Oakland firm, which has the technical expertise to perform the work required, and clearly demonstrated their understanding of the technical complexities and regulatory issues involved in the design and construction of the East Oakland Sports Center; and

WHEREAS, the City lacks the equipment and qualified personnel to perform the necessary work; and

WHEREAS, the City Council finds and determines that the performance of this contract is in the public interest because of economy; and

WHEREAS, the City Council finds that services under this contract will be temporary; and

WHEREAS, the City Council finds and determines that the performance of this contract shall not result in the loss of employment or salary by any person having permanent status in the competitive service; and
