**RESOLUTION AWARDING A GRANT AGREEMENT TO OAKLAND  
PARKS AND RECREATION FOUNDATION IN AN AMOUNT NOT TO  
EXCEED \$100,000 TO PROMOTE COMMUNITY PREPAREDNESS  
ACTIVITIES USING CALIFORNIA OFFICE OF EMERGENCY  
SERVICES GRANT FUNDING**

**WHEREAS**, in November 2019, the Oakland Fire Department (OFD), with the support of the City's Chief Resilience Officer, applied for and was later awarded a California Office of Emergency Services (Cal OES) Public Safety Power Shutoff (PSPS) Resiliency Allocation to Cities Grant ("PSPS Grant") in the amount of five hundred thousand dollars (\$500,000); and

**WHEREAS**, on June 16, 2020, City Council adopted Resolution No. 88158 C.M.S., which authorized the City Administrator or designee to enter into an agreement with Cal OES and to accept, appropriate and expend the PSPS Grant; and

**WHEREAS**, the City of Oakland entered into a grant agreement with Cal OES to administer the PSPS Grant funds in accordance with the PSPS Grant proposal, which includes a one hundred thousand dollar (\$100,000) allocation to expand community preparedness programming ("Community Partner funding"); and

**WHEREAS**, the City intends to enter into an agreement with Oakland Parks and Recreation Foundation (OPRF) to administer Community Partner funding by awarding small grants, or mini-grants, to multiple grassroots community-led institutions that are engaged in community preparedness planning activities; and

**WHEREAS**, examples of community preparedness planning activities include developing culturally-relevant disaster preparedness training, response and recovery plans, building and maintaining strong communications networks and partnering with the City to develop resilience hubs, community-serving facilities that support residents year-round with resource distribution and onsite services before, during or after a hazard event; and

**WHEREAS**, the OPRF Community Partner agreement will align with the City's mission of equitable community resilience programming, including plans to support resilience hubs, as described in the City's 2030 Equitable Climate Action Plan, the Resilient Oakland Playbook and the Local Hazard Mitigation Plan; now, therefore, be it

**RESOLVED:** That City Council hereby awards a grant agreement to Oakland Parks and Recreation Foundation to expend Community Partner funding in an amount not to exceed \$100,000 to promote community preparedness activities and align with the purpose of the PSPS Grant requirements.
