

NOTICE AND DIGEST

ORDINANCE AMENDING THE 2020 OAKLAND PARKS AND RECREATION PRESERVATION, LITTER REDUCTION AND HOMELESSNESS SUPPORT ACT TO ADD AN EXEMPTION FROM THE PARCEL TAX FOR DISTRESSED HOMEOWNERS, AS REQUIRED BY THE ACT

This ordinance would amend the voter-approved 2020 Oakland Parks and Recreation Preservation, Litter Reduction and Homelessness Support Act (the "Act") to add an exemption from the parcel tax for "distressed homeowners". The Act provides that prior to the initial imposition of the tax the Council shall adopt an exemption that applies to "distressed homeowners".

This ordinance defines distressed homeowners as an owner or a residential unit that is a unit occupied by the owner as his or her principal place of residence and that is subject to a notice of default, notice of trustee's sale, or pending tax assessor's lien sale
