A RESOLUTION AUTHORIZING THE CITY ADMINISTRATOR TO EXECUTE AN AGREEMENT BETWEEN THE CITY OF OAKLAND AND SPORTS4KIDS TO PROVIDE VIOLENCE PREVENTION SERVICES FOR A TOTAL AMOUNT NOT TO EXCEED \$94,245 THE PERIOD OF JULY 1, 2008 TO JUNE 30, 2009

WHEREAS, City of Oakland voters passed Measure Y, the Violence Prevention and Public Safety Act of 2004, in November 2004, approving a series of taxes to support violence prevention objectives, programs and services to reduce violence among children, youth and young adults in Oakland; and

WHEREAS, the City Council approved Measure Y Contracts for FY 08-09 Violence Prevention Programs on June 17, 2008 but Sports4Kids was inadvertently omitted from the resolution; and

**WHEREAS**, Sportsf4Kids has been monitored by Department of Human Services staff and deemed worthy of another year of funding; and

**WHEREAS**, Sports4Kids has demonstrated the ability to complete the terms of its current agreement by the end of Fiscal Year 2007-08; and

**WHEREAS**, projected revenues for Measure Y indicate that a cost of living adjustment of three percent can be added to the current contract amounts; and

WHEREAS, the funding for these contracts is available in Public Safety Act / 2004 Measure Y Fund (2251), DHS Administration Organization (78111), Program (PS37), DHS Measure Y Projects (G310467) and there is no impact on the General Fund.; and

**WHEREAS**, staff recommends Sports4Kids for funding for Fiscal year 08-09 for \$94,245 to provide sports programming and mentoring schools for high risk youth; and

WHEREAS, the City Council finds that this agreement shall not result in the loss of employment or salary by any person having permanent status in the competitive services; now therefore, be it

**RESOLVED:** That the City Administrator is hereby authorized to execute a grant agreement with Sports4Kids in an amount not to exceed \$94,245 in Fiscal Year 2008-09, for the purpose of funding services to at-risk youth under the Violence Prevention and Public Safety Act of 2004; and be it

**FURTHER RESOLVED**: These funds will be allocated from Public Safety Act / 2004 Measure Y Fund (2251), HHS Administration organization (78111), DHS Measure Y Project (G310467); and be it

**FURTHER RESOLVED:** That the City Administrator is hereby authorized to conduct all negotiations, execute and submit all documents, including but not limited to applications, agreements, amendments, modifications, payment requests and related actions which may be necessary in accordance with its basic purpose; and be it

**FURTHER RESOLVED:** That said agreements shall be approved as to form and legality by the Office of the City Attorney and placed on file in the Office of the City Clerk.
