INTRODUCED BY COUNCILMEMBER VICE MAYOR CAMPBELL WASHINGTON

RESOLUTION AUTHORIZING VICE MAYOR ANNIE CAMPBELL WASHINGTON AND COUNCILMEMBER ABEL GUILLEN TO TRAVEL TO LONG BEACH, CALIFORNIA TO ATTEND THE 2018 ANNUAL LEAGUE OF CALIFORNIA CITIES CONFERENCE FROM SEPTEMBER 12-14, 2018, AND BE REIMBURSED FOR NECESSARY EXPENSES

WHEREAS, Vice Mayor Annie Campbell Washington and Councilmember Abel Guillen will represent the City of Oakland at the Annual League of California Cities Conference from September 12-14, 2018; and

WHEREAS, pursuant to City Council Resolution No. 82800 C.M.S. approved by Council on June 1, 2010, which establishes a policy that Councilmembers, when seeking Council approval for travel, shall indicate whether City funds will be used when travel involves airline transportation and lodging, and shall provide an estimate of the cost of airline, lodging, per diem and conference fees when City funds are used and the source of City funding that will be used to cover the travel costs; and

WHEREAS, in compliance with City Council Resolution No. 82800 C.M.S., the estimated cost is \$525 in registration fees, up to \$390 for one night of lodging, up to \$224 for two days of per diem, and up to \$350 for air fare; and

WHEREAS, in compliance with City Council Resolution No. 82800 C.M.S., the source of City funding that will be used to cover the travel costs will be from City Council District 4 and District 2 respective funds; and

WHEREAS, Vice Mayor Annie Campbell Washington and Councilmember Abel Guillen seek Council approval of the aforementioned estimated costs to travel to Long Beach, CA to attend the Annual League of California Cities Conference, September 12-14, 2018; now, therefore, be it

RESOLVED: That all expenses incurred for said travel are hereby authorized.
