RESOLUTION NO. 9095 1st C.M.S.

RESOLUTION AMENDING RESOLUTION NO. 89787 TO CORRECT THE BUSINESS NAME FROM BONTERRA, INC. TO BONTERRA TECH LLC

WHEREAS, the City Council awarded a contract to Bonterra Tech LLC, formerly Social Solutions Global, Inc., for the term of August 1, 2022, to June 30, 2027 (Resolution No. 89380), to build and maintain a web-based data management system for the DVP through Bonterra Tech LLC's Apricot 360 platform, in an amount not to exceed Five Hundred Thirty-Three Thousand Fifty-Six Dollars (\$533,056), which includes funding for 150 user licenses and the diamond-level technical support package for the duration of the contract term; and

WHEREAS, the City Council amended Resolution No. 89380 to increase the amount of the contract with Bonterra Tech, LLC for data management system services for the period of August 1, 2022, to June 30, 2027, to fund fifty additional user licenses and downgrade the DVP's technical support package from diamond to platinum for an additional contract amount not to exceed Ninety-One Thousand Five Hundred Forty-One Dollars (\$91,541) and a contract amount not to exceed Six-Hundred Twenty-Four Thousand Five Hundred Ninety-Seven Dollars (\$624,597); and

WHEREAS, Resolution No. 89380 was amended by Resolution No. 89797; however, Resolution No. 89797 incorrectly listed the business name; now, therefore, be it

RESOLVED: That Resolution No. 89787 is hereby amended to correct the business name from Bonterra, Inc. to Bonterra Tech LLC, so that the Council authorizes an increase in the amount of a contract with Bonterra Tech LLC, formerly Social Solutions Global, Inc., for data management system services for the period of August 1, 2022, to June 30, 2027, to fund fifty additional user licenses and downgrade the DVP's technical support package from diamond to platinum, for an additional contract amount not to exceed Ninety-One Thousand Five Hundred Forty-One Dollars (\$91,541), and a total contract amount not to exceed Six Hundred Twenty-Four Thousand Five Hundred Ninety-Seven Dollars (\$624,597).

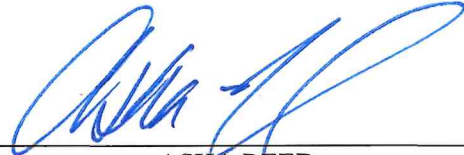
