RESOLUTION CONFIRMING THE MAYOR'S REAPPOINTMENT OF STEPHEN BEARD, AMY BURNS, MICHELLE R. HERNANDEZ, MARLENE C. HURD AND DENISE SHERER JACOBSON TO THE COMMISSION ON PERSONS WITH DISABILITIES

WHEREAS, Section 601 of the City Charter provides that members of City boards and commissions shall be appointed by the Mayor subject to confirmation by the affirmative vote of five members of the City Council; and

WHEREAS, Ordinance No. 9968 C.M.S., adopted August 5, 1980, and amended by Ordinance No. 11864 C.M.S., adopted March 12, 1996, created the Commission on Persons with Disabilities to address issues germane to accessibility, services and civil rights for persons with disabilities; and the Commission on Persons with Disabilities consists of fifteen (15) members serving three year staggered terms with no more than two consecutive terms, and 51% of Commission members must be persons with disabilities; and

WHEREAS, the Honorable Mayor Jean Quan has reappointed Stephen Beard, Amy Burns, Michelle R. Hernandez, Marlene C. Hurd and Denise Sherer Jacobson, each to serve a second three-year term subject to confirmation by the City Council; now therefore be it

RESOLVED, that pursuant to City Charter section 601, the City Council hereby confirms the Mayor's reappointment of these five individuals to the Commission on Persons with Disabilities for the terms set forth below:

Stephen Beard, Mayoral reappointment to serve the term beginning September 3, 2012 and ending September 2, 2015 filling the seat previously held by himself,

Amy Burns, Mayoral reappointment to serve the term beginning September 3, 2012 and ending September 2, 2015, filling the seat previously held by herself,

Michelle R. Hernandez, Mayoral re-appointment to serve the term beginning September 3, 2011 and ending September 2, 2015, filling the seat previously held by herself,

Marlene C. Hurd, Mayoral appointment to serve the term beginning September 3, 2011 and ending September 2, 2015, filling the seat previously held by herself.

Denise Sherer Jacobson, Mayoral appointment to serve the term beginning September 3, 2011 and ending September 2, 2015, filling the seat previously held by herself.
