RESOLUTION AUTHORIZING THE CITY ADMINISTRATOR TO ACCEPT A GIFT OF FURNITURE TO THE CITY OF OAKLAND FROM 1950 FRANKLIN STREET LLC AT A VALUE ESTIMATED AT \$1,415 FOR THE CITY OF OAKLAND

WHEREAS, 1950 Franklin Street LLC describes itself as an “Elevated & Connected Workspace” in the Heart of Oakland and has agreed to donate furniture to the City of Oakland, which is coming at a critical time during the City’s deficit; and

WHEREAS, 1950 Franklin Street LLC “offers premium coworking and private offices in the heart of Oakland’s thriving business district;” and

WHEREAS, in light of the City’s financial challenges, leveraging private donations is a critical strategy to meet operational and social service needs while upholding fiscal responsibility; and

WHEREAS, the donated furniture from 1950 Franklin Street LLC has the potential to improve functionality and comfort of City facilities for city employees and the public, while also enhancing the working environment for City employees and volunteers; and

WHEREAS, the list of donated goods is set forth in Attachment A; and

WHEREAS, Rule 21 of the Council Rules of Procedure provides that the Mayor is authorized to take such actions as would normally be taken by the Council except for certain specified matters as set forth in Rule 21 and this action, which does not require appropriation of funds, is an allowable action; and

WHEREAS, this Resolution cannot be deferred for Council approval following the Council recess because there is an immediate and urgent need to improve the functionality and comfort of City facilities for City employees and the public, while also enhancing the working environment for City employees and volunteers; now, therefore, be it

RESOLVED: That the City Administrator is hereby authorized to accept a gift of furniture from 1950 Franklin Street LLC on behalf of the City as set forth in Attachment A to this Resolution, at a value estimated at \$1,415.


