I was politically active when I was in college. I was an undergraduate student senator for two semesters and become student vice president for the third semester. When I was in San Jose State University, I founded and was first president of the university's Psychological Society. I am proud to say that the organization continues.

In 2001, I went back home to my native land Philippines and taught for two semesters voluntarily in order to share advanced knowledge with the people from where I came.

Returning to California in 2002, I work in different fields, gaining experience in customer service. I worked at Fairmont Hotel as Front Desk Receptionist and VIP Coordinator for almost two years. Forest City Enterprise hired me to be their Customer Service Specialist in Downtown San Jose for almost a year. I worked at Bank of America in Pacific Height for six months until I met my husband, Marty McCorkle, whose artwork changed my life. Since then, my dreams and goals continue to evolve around the art system.
