### **RECOMMENDATION**

A Resolution Awarding A Contract To R&S Overhead Garage Door Inc., The Lowest Responsive And Responsible Bidder For Overhead Garage Doors And Rolling Gates, Maintenance And Repair Services For 149 Roll-Up Doors And 39 Rolling Gates At 37 City Facility Locations In The Amount Not-To-Exceed Five Hundred Thousand (\$500,000) Per Year For A Four-Year Term, October 1, 2024 To September 30, 2028; With One (1) - Year Option To Extend The Agreement In The Amount Not-To-Exceed Five Hundred Thousand (\$500,000) Per Year, For Total Not-To Exceed Contract Amount Of Two Millions Five Hundred Thousand (\$2,500,000) Over A Five-Year Term, In Accord With Specification No. 910-00/Rfq 271286 And Contractor's Bid Proposal, And Waive The Local And Small Local Business Enterprise Program Requirements

#### **EXECUTIVE SUMMARY**

Adoption of the proposed resolution will allow the Oakland Public Works Facilities Services Division to continue ensuring that City-Owned facilities with overhead doors and rolling gates are operational, fully maintained, and respond to any emergency repairs in a timely manner.

#### **BACKGROUND / LEGISLATIVE HISTORY**

The Public Works Facilities Services Division is responsible for the repair and maintenance of all City of Oakland facilities. Currently, the City has 37 facilities with 149 roll-up doors and 39 rolling gates. Of the 188 roll-up doors and rolling gates, 96 are at fire stations where emergency response equipment is housed (**Table 1**). Maintenance and service of the doors requires specific expertise and knowledge, a failure of the door or gate could be critical at any of the City's Fire Stations, Police Stations, or other emergency response facility or Corp yard. City staff are not equipped or trained to perform installations, maintenance repairs, service, or installation, and the expertise required to install and maintain these doors and gates makes having a contractor necessary.

# **ANALYSIS AND POLICY ALTERNATIVES**

The Oakland Public Works Department (OPW), Bureau Maintenance and Internal Services (BMIS), Facilities Division must procure professional services for installation, maintenance, and repair for 149 roll-up doors and 39 rolling gates at 37 City facilities.

The City lacks the equipment and qualified personnel to perform the necessary work, that the performance of this contract is in the public interest because of economy or better performance and that this contract is of a professional, scientific, or technical nature. City-Owned facilities with overhead roll-up doors and rolling gates are aging; most are at fire stations, where services are often needed, so 24-hour immediate service is essential.

As such, the City of Oakland conducted a Request for Proposal (RFP) for installation, maintenance, and repair services for 149 roll-up doors and 39 rolling gates.

On February 16, 2024, Specification No. 910.00/RFQ 271386 to provide on-call overhead door and rolling gate installation and repair was sent to ten (10) qualified business enterprises and posted on the City's web and advertised in the City's official newspaper in accordance with the City of Oakland Municipal Code (OMC) 2.04.050.

On March 14, 2024, the City Clerk's Office received three (3) bid proposals from R&S Garage Doors., Inc, San Leandro, CA, McKendry Door Sales, Santa Fe Springs, CA, and Nor-Cal Overhead., Inc, Oakley, CA (bid amount listed in Attachment 1) for specification No. 910.00/RFP/Q 271386 to provide on-call overhead door and rolling gate installation and repair, and R&S Overhead Garage Doors, Inc. was deemed as the lowest, responsive, and responsible bidder.

Resolution No. <u>13460 C.M.S.</u> and <u>13467 C.M.S.</u> require a minimum 50-percent (50%) Local Business Enterprise/Small Local Business Enterprise (LBE/SLBE) participation for all purchase of commodities, goods, and associated services for contracts valued at or over fifty thousand dollars (\$50,000) when there are at least three certified business listed in the industry, trade, or profession that constitutes a major category of work. However, the Council may waive the City's LBE/SLBE requirements due to a lack or limited availability of SLBEs or LBEs and because it is in the best interests of the City to do so.

The Purchasing Department did not receive bids from any certified LBEs/SLBEs that can perform the services to the City that are required under this contract. Thus, staff requests that the Council waive the LBE/SLBE utilization requirements for this proposed contract award on this basis and because it is in the best interests of the City to do so because of the reasons discussed in this report.

Staff recommends that the City Council adopt the proposed resolution awarding a contract to R&S Overhead Garage Doors, Inc., the lowest responsive and responsible bidder, to provide on-call overhead door and rolling gate installation and repair services in the amount not-to-exceed \$500,000 per year for a four-year term, October 1, 2024, to September 30, 2028, with one (1) one-year option to extend the contract, in the amount not-to-exceed \$500,000 per year for a total not-to-exceed contract amount of \$2,500,000 over a five-year term in accord with specification No. 910-00/RFQ 271386 and contractor's bid proposal, and waive the local and small local business enterprise program requirements.

Approval of the proposed resolution will keep City-Owned facilities with rolling gates and roll up doors operational and fully maintained which allowing for ongoing Oakland Public Works operations to support City critical services and Citywide priorities, including **holistic community safety** and **vibrant**, **sustainable infrastructure**.

# **FISCAL IMPACT**

The contract will be for \$500,000 annually for the amount not-to-exceed \$2,500,000 over the five-year period term from FY2025 to FY2030.

This contract will be funded from the FY2025 budget Facilities Services Fund (4400) Facilities: Maintenance ORG (30556), DP300 Administrative Project (1000010), and within each requesting City Department. There is no minimum commitment to this contract, and funds will not be committed unless funding is identified.

# PUBLIC OUTREACH / INTEREST

The services do not require any further public outreach other than the required posting on the City's website and the City's official Newspaper.

# **COORDINATION**

The Oakland Public Works Department prepared the requested action. This report and resolution were reviewed by the Office of the City Attorney and Budget Bureau.

#### **SUSTAINABLE OPPORTUNITIES**

**Economic**: Implementation of the proposed contract for service will ensure continuous upkeep and safety to the City's facilities with roll-up doors and rolling gates.

**Environmental**: The Facilities Services Division strives to maintain current industry standards to all City facilities. There are no negative impacts on the surrounding environments.

**Race & Equity:** The services this cooperative agreement will support City of Oakland operations. As the City's budgeted activities increasingly prioritize race & equity, these agreement services support that mission.
