**RESOLUTION CONFIRMING THE MAYOR'S APPOINTMENT OF  
JIAN HONG AND ELISE BERNSTEIN, AND THE REAPPOINTMENT  
OF GRACE WRIGHT, PHYLLIS STEVENSON, AND LORRAINE  
ROSENBLATT TO THE COMMISSION ON PERSONS WITH  
DISABILITIES**

**WHEREAS**, Section 601 of the City Charter provides that members of City boards and commissions shall be appointed by the Mayor subject to confirmation by the affirmative vote of five members of the City Council; and

**WHEREAS**, Ordinance No. 9968 C.M.S., adopted August 5, 1980, and amended by Ordinance No. 11864 C.M.S., adopted March 12, 1996, created the Commission on Persons with Disabilities to address issues germane to accessibility, services and civil rights for persons with disabilities; and

**WHEREAS**, the Commission on Persons with Disabilities consists of fifteen (15) members serving three-year staggered terms with no more than two consecutive terms; and

**WHEREAS**, 51% of Commission members must be persons with disabilities; and

**WHEREAS**, the Honorable Mayor Libby Schaaf has appointed Jian Hong and Elise Bernstein, and reappointed Grace Wright, Phyllis Stevenson, and Lorraine Rosenblatt subject to confirmation by the City Council; now, therefore, be it

**RESOLVED:** That pursuant to City Charter section 601, the City Council hereby confirms the Mayor's following appointments to the Commission on Persons with Disabilities:

Jian Hong for a three-year term beginning September 3, 2013 and ending September 2, 2016, filling the seat previously held by Lori Ann Dotson

Elise Bernstein for a three-year term beginning September 3, 2012 and ending September 2, 2015, filling the seat previously held by Lateef McLeod; and be it

**FURTHER RESOLVED:** That pursuant to City Charter section 601, the City Council hereby confirms the Mayor's following reappointments to the Commission on Persons with Disabilities:

Grace Wright for a three-year term beginning September 3, 2014 and ending September 2, 2017 filling the seat previously held by herself

Phyllis Stevenson for a three-year term beginning October 19, 2014 and ending October 18, 2017 filling the seat previously held by herself

Lorraine Rosenblatt for a three-year term beginning September 3, 2014 and ending September 2, 2017 filling the seat previously held by herself.
