This letter is to express my interest in becoming the next District 3 appointee to the Community Policing Advisory Board (CPAB). It would be an honor to serve my beloved city of Oakland and its residents as a representative on this board.

I am a 30 year resident of Oakland, and my interest derives from these many years of residency, in which, I have been involved in community organizing, both in business as a public relations practitioner and as a civic organizer. During these years also, I have seen our beloved city go from relatively calm buoyancy, to a crime ridden haven for deviants, which in large part has affected the relationship between law enforcement and various neighborhoods.
