RE: A Supplemental Report 1) Explaining The Rationale For Retaining 150 Vehicles That Had Been Marked As Possibly Underutilized, 2) Providing A Utilization Report For Staff Cars By Agency, And 3) Answering The Question Whether The City Can Have More Pool Cars Either Leased Or Purchased

SUMMARY

On March 28, 2006, staff presented to the Finance and Management Committee an overview of the City's automotive and equipment fleet. The Committee requested additional information concerning why 200 cars were taken from agencies and 150 returned, and the rationale for the decision. The Committee also requested a utilization report by agency for staff cars and an explanation of why the cars are needed, and questioned whether the City could lease or purchase pool cars.

KEY ISSUES AND IMPACTS

Underutilization and Retention

The Equipment Services Division, in its role as advisor to agencies and departments, requested justification for the use of 200 low-usage vehicles that were possibly underutilized. As a general rule, staff cars are expected to accumulate 60,000 miles at the end of their ten-year service life. In order to meet this criterion, a staff car is expected to accumulate approximately 500 miles per month or 25 miles per workday to be considered effectively utilized. Described below is the process followed in determining the low-usage vehicles and the basis for retaining the vehicles for use by the respective agencies.

In February 2003, the Public Works Agency undertook a review of City fleet operations. The objective of the review was to identify those vehicles that were underutilized and to reassign them in order to maximize the City's fleet investment. In that review, 200 vehicles were identified as *possibly* being underutilized.

In April 2003, the City Manager sent a memorandum to all agency heads explaining the criteria the Public Works Agency used to determine low vehicle usage, and requested that agencies/departments either return the low-usage vehicles for reassignment or justify retention of the vehicle.

Equipment Division staff developed a form, "Justification for Retention of City-owned Vehicles" that was to be completed by the manager of the assigned low-usage vehicle explaining the need for retaining vehicles in the fleet. The agency director or his/her designee was required to approve the justification and acknowledge the following statement in justifying retention: "*I acknowledge that the vehicle described above does not meet the minimum annual mileage/utilization criteria set for the assignment of City-owned vehicles. I have reviewed the need for this vehicle to remain in my fleet and acknowledge the cost both to my agency and to the City of retaining this vehicle. I feel the cost of this vehicle is appropriate.*"

In April and May 2003, the Equipment Division received retention justification forms for each of the vehicles not removed from service.

The full implementation of the Maximus FASuite fleet management software will enable the Equipment Service Division to provide activity-based costing for all fleet services. This will afford user departments more control over their vehicle and equipment budgets. There will be a financial incentive for agency directors, department heads, and division managers to release underutilized vehicles to fleet management and use less costly methods such as use of short-term pool vehicles, periodic rental vehicles, etc., for delivering goods and services.

Staff Car Utilization by Agency

The Equipment Services Division conducted a fleet validation study in December 2005. The study verified agency/department vehicle assignments, garage locations and source of funding. Staff then undertook a survey of fleet utilization. Attachment A shows the utilization for staff sedans and station wagons, as requested by the Committee.

Equipment Services staff has begun discussion with various agencies to discuss vehicle utilization and to determine staff transportation needs in order to migrate the underutilized vehicles into a Citywide pool housed downtown.

The Committee also requested a listing by agency of City-paid parking at the City Center West, Clay Street and Dalziel Building garages (see Attachment B).

Pool Cars – Leased vs. Purchased

The Equipment Services Division has maintained a pool of four compact staff cars in the Clay Street Garage for occasional, short-term use by City associates who do not have an assigned City-owned vehicle. Over the years, the City's fleet of assigned vehicles has grown so that use of unassigned pool vehicles had become sporadic. This situation is expected to change as the Equipment Services Division is re-evaluating the use of staff cars and working with agencies to eliminate or reassign underutilized fleet vehicles. As underutilized vehicles are reassigned, staff anticipates an increased demand in the use of short-term pool vehicles.

In reviewing fleet procedures, best business practice recommends establishing a centralized, larger motor pool to provide vehicles for those organizations that are currently underutilizing their

departmentally assigned vehicles. Expanding the City-owned pool will support the Mayor's and Council's goals to model best practices to improve customer service and to be a fiscally sound and efficiently run city; to develop and institutionalize sound financial management policies and practices; and to maximize the value provided by each dollar spent in outside contracts and purchases.

A review of the utilization of the staff sedans and station wagons shows that several vehicles are candidates for reassignment to a general pool. At this time, staff does not recommend exploring the option to either lease or purchase new vehicles for a general pool as there are sufficient vehicles in the City's current fleet to cover its pool vehicle needs.

ACTION REQUESTED OF THE CITY COUNCIL

Staff recommends that Council accept the supplemental report.


