INTRODUCED BY COUNCILMEMBER REBECCA KAPLAN

RESOLUTION AUTHORIZING A GRANT OF \$5,000 FROM COUNCILMEMBER KAPLAN'S GRAFFITI ABATEMENT MURAL AND GREEN WALL FUNDS TO ARTIST DEBRA KOPPMAN FOR A MURAL ON THE CORNER OF MAPLE STREET AND MACARTHUR BOULEVARD IN THE DIMOND NEIGHBORHOOD

WHEREAS, on June 27, 2013, the City Council adopted a budget that set aside Graffiti Abatement funds for Murals and Green Walls for Councilmembers to grant, subject to Council approval, to address graffiti within their districts; and

WHEREAS, PG&E located at 2971 MacArthur Boulevard has authorized artist Debra Koppman to create a mural on the wall along Maple Street and the corner of MacArthur Blvd to prevent the continuation of graffiti on the wall; and

WHEREAS, Councilmember Kaplan wishes to grant a portion of her Graffiti Abatement Mural and Green Wall Funds to the artist Debra Koppman for a mural project located at 2971 MacArthur Boulevard to deter graffiti and blight; and

WHEREAS, in conformance with City requirements, the artist, Debra Koppman will provide documentation for the use of the Councilmember's Graffiti Abatement Mural and Green Wall funds, including any permits required and permission from the property owners to install the mural; now, therefore, be it

RESOLVED: That the City Council authorizes a grant of \$5,000 from Councilmember Rebecca Kaplan's Graffiti Abatement Mural and Green Wall funds to Debra Koppman for a mural on 2971 MacArthur Boulevard on the corner of Maple and MacArthur in the Dimond neighborhood; and be it

FURTHER RESOLVED: That the City Administrator is authorized to execute a grant agreement with Debra Koppman in an amount not to exceed \$5,000 for the above purpose, subject to approval as to form and legality by the City Attorney.
