Pursuant to Section 401 of the Charter, the City Attorney has prepared and requests your approval of a resolution authorizing compromise and settlement of the above-entitled action for the sum of Thirteen Thousand Dollars and No Cents (\$13,000.00), payable to Plaintiff Jules Masalunga and, his attorney Eduardo Gonzalez, Esq..

This action arises out of an automobile accident involving an on-duty police officer at the intersection of Broadway and 27<sup>th</sup> Street on February 23, 2007. The settlement is recommended to avoid the risk of an adverse trial result and potentially greater economic exposure for the City.
