AND LOREN TAYLOR

**RESOLUTION AUTHORIZING REIMBURSEMENT FOR COUNCILMEMBERS SHENG THAO, NIKKI FORTUNATO BAS AND LOREN TAYLOR'S COST NOT TO EXCEED \$1,200 PER COUNCILMEMBER FROM THE COUNCIL CONTINGENCY FUND FOR TRAVEL TO SACRAMENTO, CA FOR ATTENDANCE AT THE LEAGUE OF CALIFORNIA CITIES NEW MAYORS AND COUNCIL MEMBERS ACADEMY FROM JANUARY 22-24, 2020.**

**WHEREAS**, City Council Resolution No. 82800 CM.S. approved by Council on June 1, 2010 establishes a policy that Councilmembers, when seeking Council approval for travel, shall indicate whether City funds will be used when travel involves airline transportation and lodging and shall provide an estimate of the cost of airline, lodging, per diem and conference fees when City funds are used as well as the source of City and/or Redevelopment Agency funding that will be used to cover the travel costs; and

**WHEREAS**, Councilmembers Sheng Thao, Nikki Fortunato Bas, and Loren Taylor in order to train to become more effective municipal leaders and to refresh and hone their skills and habits which lead to good and effective governance will travel to The League of California Cities New Mayors and Council Members Academy from January 22<sup>nd</sup> through January 24<sup>th</sup> of this year; and

**WHEREAS**, the League of California Cities New Mayors and Council Members Academy provides critical training on important, fundamental topics for local government taught by subject matter experts and seasoned elected officials; and

**WHEREAS**, in compliance with City Council Resolution No. 82800 C.M.S., the cost for Councilmembers Sheng Thao, Nikki Fortunato Bas, and Loren Taylor's travel to Sacramento, CA is approximately \$625 each in conference fees, up to \$66 each in per diem costs for 2 days for a total of approximately \$132 each, and approximately \$195 in total lodging costs per night for 2 nights for a total of \$390 each; and

**WHEREAS**, in compliance with City Council Resolution No. 82800 C.M.S., the source of City funding that will be used to cover the travel costs will be from the City Council Contingency Project fund; and

**WHEREAS**, Councilmembers Sheng Thao, Nikki Fortunato Bas, and Loren Taylor seek Council approval of the aforementioned estimated costs; now, therefore, be it

**RESOLVED:** That all expenses incurred for said travel of Councilmembers Sheng Thao, Nikki Fortunato Bas, and Loren Taylor to attend the League of California Cities New Mayors and Council Members Academy in Sacramento, CA from January 22<sup>nd</sup> to January 24<sup>th</sup> 2019 are hereby authorized for reimbursement.
