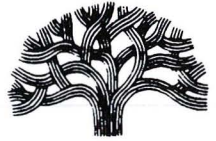

RESOLUTION AUTHORIZING AND DIRECTING THE CITY ATTORNEY TO COMPROMISE AND SETTLE THE CLAIM OF SHIRLEY ZHANG, IN THE AMOUNT OF SEVEN THOUSAND FIVE HUNDRED DOLLARS AND 00/100 CENTS (\$7,500.00) AS THE RESULT OF DAMAGES SUSTAINED FROM AN AUTOMOBILE COLLISION ON OCTOBER 26, 2013 (OAKLAND POLICE DEPARTMENT—AUTOMOBILE COLLISION)

WHEREAS, claimant alleges that on October 26, 2013, she sustained damages as a result of an automobile collision involving a City vehicle; and

WHEREAS, the claimant filed the above entitled claim seeking payment for said damages; and

WHEREAS, the City of Oakland has determined that settlement in this amount, without an admission of liability, is in the best interest of the City; now therefore, be it
