Resolution Appropriating Measure DD Bond Interest Money To The Children's

Fairyland Project (C241810) In The Amount Of One Hundred Eighty-One

Thousand Dollars (\$181,000.00)

#### **SUMMARY**

A resolution has been prepared appropriating \$181,000 of Measure DD bond interest money to the Children's Fairyland project. The additional funds are needed to help cover higher-than-expected construction costs on the Fairyland project.


The Children's Fairyland Project is consistent with the Mayoral and City Council Goal to "Build Community and Foster Livable Neighborhoods," by providing for clean and well-maintained facilities, amenities, parks and recreational facilities. The project is located in Council District 3.

## FISCAL IMPACT

Measure DD bond principal money is placed in interest-bearing investments until needed. The interest accrued to date is approximately \$4.7 million within the Measure DD fund (5320), Treasury Organization (08721), Interest account (44113). In December 2005, City Council allocated \$2 million of bond interest money to the Studio One project, leaving approximately \$2.7 million currently available.

Approval of this resolution will authorize the appropriation of \$181,000 in order to complete improvements in the Children's Fairyland Project. The funding request is on behalf of Oakland Children's Fairyland, Inc., managers of the construction project. Funding will be appropriated to the Measure DD Fund (5320), CIP PWC Construction Services Organization (92232), Children's Fairyland Project (C241810).

It is preferred that bond Series A principal money be spent before accrued interest money is spent. Therefore, if the Fairyland project principal money is spent before all other Measure DD principal money is spent, principal funds may be temporarily reallocated to the Fairyland project from other Measure DD Lake Merritt Series A projects that are delayed or on hold. Once the Series A principal funds are spent, the Measure DD interest money will be used to replenish the borrowed funds.



## **BACKGROUND**

In July 2003, City Council appropriated \$3 million for the Children's Fairyland project. This project is managed by Oakland Children's Fairyland, Inc. (OCF). To date, sets have been renovated and an addition to the puppet theater has been completed. The largest single project undertaken is a new pavilion and associated infrastructure upgrades. Bids were opened earlier this year and were approximately \$1 million above the architect's cost estimate. To move the project forward, OCF has scaled back the scope of the project, engaged in value engineering review, and is working to raise additional private funds. OCF has asked that \$181,000 of Measure DD interest money be appropriated to the project to help close the funding gap.

## KEY ISSUES AND IMPACTS

The Measure DD project at Fairyland includes renovation of sets, expansion of the puppet theater, utility infrastructure upgrades, and construction of a new pavilion. Recent construction bids for the pavilion and utility infrastructure came in significantly higher than expected. OCF is employing a variety of approaches to closing the funding gap, including value engineering and fundraising from private sources. Because Fairyland's funding needs are immediate, OCF has requested that \$181,000 of Measure DD interest money be appropriated now so that a construction contract can be signed and the project can be completed. If this interest money is not appropriated, OCF will not be able to afford the fabric roof structure over the pavilion stage and seating area. This roof would shelter the audience and stage players from sun and rain, and is an important project element. Waiting until other sources of funding eventually become available would not take advantage of construction efficiencies and would not provide comfort for the pavilion users in the interim period.

# SUSTAINABLE OPPORTUNITIES

<u>Economic:</u> The Fairyland project will generate jobs for Oakland residents, and business tax, sales tax and other revenues for the City by those who work on the project.

<u>Environmental</u>: The contractors working at Fairyland will be required to use recyclable construction materials to the extent feasible and are required to recycle construction debris. Improvements to the drainage system will help keep Lake Merritt clean.

Social Equity: Children's Fairyland serves residents city-wide.

# DISABILITY AND SENIOR CITIZEN ACCESS

The Children's Fairyland project is being designed in compliance with ADA requirements.
