RE: A Report And Resolution Authorizing The City Administrator Or His Designee To: 1) Enter Into An Urban Area Security Initiative (UASI) Grant Administration Agreement With The City and County Of San Francisco For Receipt Of Fiscal Year 2010 Urban Area Security Initiative (UASI) Grant Funds In An Amount Up To One Million, Two Hundred and Twenty-Five Thousand Dollars (\$1,225,000), And 2) Accept, Appropriate And Administer Said UASI Grant Funds, And 3) Approve The 2010 UASI Preliminary Spending Plan And Waive City Of Oakland Central Services Overhead (CSO) Fees Of Twenty-Seven Thousand Dollars (\$27,000), And 4) Expend Funds In Accordance With Said Preliminary Spending Plan Without Further Council Authorization, Including Purchases In Excess Of The City Administrator's Purchasing Authority Of Equipment And Services Required By The Grant, Provided Federal And City Bidding Requirements And Request For Proposal/Qualification Requirements And Purchasing Programs And Policies Are Followed

SUMMARY

The proposed report and resolution seek the City Council's approval to enter into an Urban Area Security Initiative (UASI) Grant Administration Agreement to receive up to one million two hundred and twenty-five thousand dollars (\$1,225,000) in Fiscal Year 2010 UASI grant funds, waive the Central Service Overhead (CSO) fees of \$27,000, and authorize the City Administrator or his designee to administer all the programs included as part of the grant performance and requirements, including purchases of equipment and services required by the grant in accordance with the approved spending plan, in excess of his purchasing authority without further Council review or action. All such purchases will be done in accordance with federal and City purchasing requirements and programs.

The grant performance period for the City of Oakland for the FY 2010 UASI grant will be July 1, 2011 through June 30, 2012, but may be extended if grant funds are remaining until February 1, 2013.

FISCAL IMPACT

Approval of this report and proposed resolution will authorize the City of Oakland to enter into an Urban Area Security Initiative (UASI) grant administration agreement and accept an appropriation of up to \$1,225,000 in FY 2010 UASI grant funding. The primary objectives of the FY 2010 UASI grant funding is to enhance the City of Oakland's overall emergency management plan and augment the City of Oakland's emergency prevention, mitigation, response and recovery capabilities, which will provide regional benefits by increasing the region's emergency response capacity.

The FY 2010 UASI Grant funding is to be appropriated into U.S. Department of Homeland Security Fund (2123), Office of Emergency Services Organization (20711), a grant project to be determined, Office of Emergency Services/Homeland Security Program (PS21), various accounts per the approved grant's line-item budget. The full grant fund will be appropriated to the Miscellaneous Federal Grants Revenue Account (46129).

The Oakland Fire Department, Office of Emergency Services and Homeland Security Division will be responsible for administering this UASI grant agreement and ensuring that all requirements set forth in the agreement are met.

At this time, the Urban Area Security Initiative (UASI) grant received by the City of Oakland does not require any matching funds and there are no other associated fees with this UASI grant distribution and administration agreement.

Staff is requesting that City Council waive the City of Oakland Central Services Overhead (CSO) costs of \$27,000. The CSO costs and all other indirect costs have been waived since Federal FY 2004 when Oakland began receiving UASI grant funding. Additionally, all the core urban area cities (including San Francisco and San Jose), receiving direct UASI grant funding awards have been requested to and have waived the CSO costs since Federal FY 2004. The amount requested to be waived is 2.7% of the total grant amount. The City's return on investment for this grant funding opportunity is monumental.

BACKGROUND

On January 3, 2006, the Department of Homeland Security announced that the separate Urban Area Security Initiative (UASI) entities that included the cities of Oakland, San Francisco and San Jose would be consolidated into one urban area for purposes of the UASI funding provided by the Federal government to high threat/high risk areas. The Bay Area "UASI" encompasses ten counties, three major cities, over 100 municipalities and involves an area of 8,800 square miles with significant critical infrastructure including three international airports, two major ports, international icons, and centers of commerce and technology that are critical not only to the Bay Area economy, but also to the national and global economies. The Bay Area UASI contains over seven million residents.

The Bay Area UASI Approval Authority is comprised of seven members that represent the three (3) core cities: Oakland, San Jose and San Francisco and the three (3) core counties: Alameda, Santa Clara and San Francisco, and a Coastal Regional Cal EMA (California Emergency Management Agency) representative. This approval body is responsible for the overall oversight of the regional UASI grant funds and all affiliated programs, projects and activities. Since the FY 2006 UASI grant, the City and County of San Francisco was selected as the fiscal agent for all UASI grants by the UASI Approval Authority.

KEY ISSUES AND IMPACTS

The purpose of the FY 2010 Super Urban Area Security Initiative Grant, passed through the California Office of Homeland Security from the United States Department of Homeland Security, is to provide financial assistance to the San Francisco Bay Area Region to address the unique equipment, training, planning, and exercise needs of large urban areas, and to assist them in building an enhanced and sustainable capacity to prevent, respond to and recover from threats or acts of terrorism. The allowable scope of activities includes an all-hazards approach to catastrophic events, such as major earthquakes, provided that these activities also build capabilities that relate to terrorism.

The Bay Area region will continue to utilize the originally adopted governance structure and submit an executed Governance Structure Memorandum of Understanding (MOU) that will be valid through December 31, 2011, that was approved by all responsible parties and their elected officials during calendar year 2008. The Oakland City Council approved the UASI Governance Structure MOU and approved Oakland entering into such agreement on July 1, 2008, Resolution Number 81421 C.M.S.

The Urban Area Security Initiative (UASI) governance structure has been very effective in representing the interest of all parties within the Bay Area Region. The Bay Area UASI Approval Authority governance structure makes decisions regarding funding and homeland security grant funded programs, projects and activities for the duration of each grant performance period. As previously mentioned, the Approval Authority structure was approved by the Department of Homeland Security and California Office of Homeland Security and is comprised of a Memorandum of Understanding between the core cities of San Francisco, Oakland, and San Jose and the core counties of San Francisco, Alameda and Santa Clara. The structure of the UASI Approval Authority Board will be expanded to include up to five (5) additional new members for the FY 2011 and future UASI grant applications and governance.

In Federal FY 2006, the UASI program changed from an allocation process (using a formula based on threat/risk and population) to a competitive grant process and all Urban Areas are required to submit substantive grant applications for emergency management and homeland security program initiatives and to justify to the Federal government the need for funding. There was also a separate threat/risk factor for each Urban Area, determined solely by the Federal government, applied to the grant funding allocation formula.

This year's grant application process has involved numerous meetings with hundreds of participants from throughout the region. As part of the allocation and grant process, the urban areas were required to engage in an additional process to prioritize the grant proposal funding and projects based on their allocations.

PROGRAM DESCRIPTION

As the UASI program has been a regional program since 2006, Oakland, San Francisco and San Jose no longer automatically receive separate UASI funding and must submit grant proposals through the appropriate UASI channels for regional planning grant funding approval. Grant funding decisions are made through a competitive process and are based on a risk-based allocation.

The City of Oakland grant proposals that will be funded by up to \$1.225 million were approved because they were in alignment with the authorized program initiatives, they met regional as well as local benefit criteria, and the deliverables could be met within the grant performance periods.

The following program initiatives have been authorized and approved by the United States Department of Homeland Security, the California Office of Homeland Security and the Bay Area UASI Approval Authority

1) Enhance Interoperable and Survivable Communications

Projects include:

- Continued expansion of the regional public safety communications systems.
- Continued studies to determine the most efficient and cost effective methods to achieve regional voice and data communications interoperability.

2) Regional Exercise Program

Projects Include:

- A SWAT and Multi-Disciplines Tactical Regional Exercise, named Urban Shield each October.
- Continue integrated training and exercises.
- Continue "train-the-trainer" programs.
- Provide training and exercises to meet identified priorities and fill gaps.
- Provide training materials to enhance local facilities' training programs.

The City of Oakland will receive up to \$10,000 in grant funding to support Law Enforcement, Fire Department, and Emergency Management training programs.

3) Citizen Preparedness and Participation

Projects Include:

- Fund new and existing citizen preparedness and public outreach programs through Operational Areas (counties) by population and urban cities.
- Fund citizen preparedness programs using a competitive process.

4) Information Sharing and Collaboration

Projects Include:

- Support the established Bay Area Region Fusion Center.
- Continue regional staffing for the Northern California Regional Intelligence Center.

The Oakland Fire Department has a staff person funded by the Northern California Regional Intelligence Center (NCRIC) that works out of the Center and provides critical information to City agencies. Funding was approved by City Council on May 18, 2010, Resolution Number 82770 C.M.S.

5) Enhance Catastrophic Incident Planning and Regional Collaboration

Projects Include:

- Enhance and expand regional planning capabilities.

The City of Oakland will receive up to \$610,708 for its regional planning programs and projects.

The breakdown for this funding is as follows:

The FY 2010 UASI grant will reimburse the City of Oakland for Oakland's Homeland Security eligible projects, programs and emergency planning staff up to \$610,708. UASI pre-approved, eligible expenses will be related to emergency planning salaries, supplies, contract services and equipment.

The proposed expenditure plan is as follows:

- Four (4.0) full-time (FTE) positions that will continue to work for the Oakland Fire Department, Office of Emergency Services. The positions will be funded by the UASI grant for the purpose of sustaining and completing projects funded under the UASI Program grants from FY 2005 to current. The OFD OES staff will oversee new FY 2010 projects that have a direct positive impact and benefit to the City of Oakland and also provide regional benefits. These projects include but are not limited to: emergency planning, training, exercises, participating in the

regional grant oversight groups, representing Oakland in the UASI working groups and ensuring compliance with national Homeland Security initiatives. The total costs for these positions from July 1, 2011 through June 30, 2012, including benefits are approximately \$610,700. The job descriptions for these positions are attached in Appendix A.

It is anticipated that the four (4.0) FTEs that will be funded by the FY 2011 UASI grant will continue to be funded with UASI grant awards in future years. The Bay Area UASI Approval Authority is in the process of submitting the FY 2011 UASI grant proposal, which if approved would provide funding for up to four (4.0) FTEs from July 1, 2012 – June 30, 2013. Once the UASI grant funding is either exhausted or the UASI grant position(s) are discontinued, the incumbents in the four (4.0) FTEs will be released from their positions.

Additionally, as part of the personnel funding reference above, the FY 2010 UASI grant provides a subsidy of \$8,292 for an existing Accountant III position in the Oakland Fire Department, Fire Administration that will spend 5% of work time as a Resource Planner for the FY 2010 UASI grant program to assist in maximizing resources, budget and human capital.

A total of \$595,000 will also be utilized to purchase equipment, supplies and contract services needed by Police and Fire Departments that will augment our emergency management and response capabilities as well as provide regional benefit. All equipment purchased with UASI grant funds must be listed on the Federal 2010 Authorized Equipment List (AEL) and be approved by the State of California prior to purchase. The aforementioned staffing, equipment and supplies expenditures represent the City of Oakland's pre-approved eligible expenses of up to \$1,225,000.

6) **Strengthen Medical and Public Health Preparedness**

Projects Include:

- Continue to develop strategic plans.

7) **Chemical, Biological, Radiological, Nuclear, and Explosive (CBRNE) Detection and Response**

Projects Include:

- Continue to address and prioritize CBRNE gaps from 2008 Bay Area UASI Strategic Plan.
- Continue to enhance bomb squad robotic and CBRNE capabilities.
- Enhance Fire Department Hazardous Materials Response Teams' capabilities in the Bay Area.

SUSTAINABLE OPPORTUNITIES

Economic: The FY 2010 UASI grant performance period for the City of Oakland will be from July 1, 2011 through June 30, 2012. The projects within the program will be completed in phases so that they may be completed either before or not later than the end of the grant period. The FY 2010 UASI grant funds specifically earmarked for Oakland will provide continued funding for Oakland Homeland Security Unit's four (4) full-time positions and also provide for local purchasing opportunities during the grant award period.

Environmental: There are no direct environmental benefits related to this grant project.

Social Equity: The funded UASI projects explicitly incorporate consideration for special needs populations which include but are not limited to non-English speaking residents and economically disadvantaged residents. The specific projects are: Medical Surge, Mass Care, and Community Resiliency. The FY 2010 UASI grant projects will also help to ensure social equity during catastrophic incidents.

DISABILITY AND SENIOR CITIZEN ACCESS

At least two (2) of the FY 2010 UASI projects that have been approved and funded explicitly incorporate consideration of persons with disabilities and senior citizens: Medical Surge and Community Resiliency. These UASI grant projects provide a specific focus on persons with disabilities and senior citizens to ensure regional equal access during major emergencies.

RECOMMENDATION AND RATIONALE

The City of Oakland is committed to cooperating with our regional partners to detect, prevent, prepare for, respond to, and recover from human-caused and natural disasters.

To sustain and enhance the City of Oakland's ability to effectively carry out the FY 2010 UASI grant edicts, it is recommended that City Council approve the report and resolution set forth that authorizes the City Administrator or designee to carry out the requirements, programs and activities necessary to accept, appropriate and spend the grant funding awarded to the City of Oakland.


The FY 2010 UASI grant funding will greatly enhance the City of Oakland's ability to effectively prepare for, respond to, and recover from, major emergencies.

ACTION REQUESTED OF THE CITY COUNCIL

It is requested that the City Council authorize the City Administrator or his designee to: 1) enter into an Urban Area Security Initiative (UASI) grant administration agreement with the City and County of San Francisco for receipt of Fiscal Year 2010 Urban Area Security Initiative (UASI) grant funds in an amount up to one million, two hundred and twenty-five thousand dollars (\$1,225,000), and 2) accept, appropriate and administer said UASI grant funds, and 3) approve the 2010 UASI preliminary spending plan and waive City of Oakland central services overhead (CSO) fees of twenty-seven thousand dollars (\$27,000), and 4) expend funds in accordance with said preliminary spending plan without further Council authorization, including purchases in excess of the City Administrator's purchasing authority of equipment and services required by the grant, provided federal and City bidding requirements and request for proposal or qualification requirements and purchasing programs and policies are followed.



RESOLUTION AUTHORIZING THE CITY ADMINISTRATOR OR HIS DESIGNEE TO:

- 1) **ENTER INTO AN URBAN AREA SECURITY INITIATIVE (UASI) GRANT ADMINISTRATION AGREEMENT WITH THE CITY AND COUNTY OF SAN FRANCISCO FOR RECEIPT OF FISCAL YEAR 2010 URBAN AREA SECURITY INITIATIVE (UASI) GRANT FUNDS IN AN AMOUNT UP TO ONE MILLION TWO HUNDRED AND TWENTY-FIVE THOUSAND DOLLARS (\$1,225,000), AND**
- 2) **ACCEPT, APPROPRIATE AND ADMINISTER SAID UASI GRANT FUNDS, AND**
- 3) **APPROVE THE 2010 UASI PRELIMINARY SPENDING PLAN AND WAIVE CITY OF OAKLAND CENTRAL SERVICES OVERHEAD (CSO) FEES OF TWENTY-SEVEN THOUSAND DOLLARS (\$27,000), AND**
- 4) **EXPEND FUNDS IN ACCORDANCE WITH THE SAID PRELIMINARY SPENDING PLAN WITHOUT FURTHER COUNCIL REVIEW OR ACTION, INCLUDING THE PURCHASE IN EXCESS OF THE CITY ADMINISTRATOR'S PURCHASING AUTHORITY OF EQUIPMENT AND SERVICES REQUIRED BY THE GRANT, PROVIDED FEDERAL AND CITY ADVERTISING, BIDDING AND REQUEST FOR PROPOSAL/QUALIFICATION REQUIREMENTS AND OAKLAND'S PURCHASING PROGRAMS AND POLICIES ARE FOLLOWED**

WHEREAS, on January 3, 2006, the Department of Homeland Security announced that the separate Urban Areas Security Initiative (UASI) entities including the cities of Oakland, San Francisco and San Jose would be consolidated into one Urban Area for purposes of the UASI Grants referred to as the Bay Area "UASI"; and

WHEREAS, the City of Oakland grant proposal was approved and the City of Oakland is being awarded a grant allocation of one million two hundred twenty-five dollars (\$1,225,000), by the Fiscal Year (FY) 2010 UASI Grant governing body as part of an investment for the regional planning, training, exercises and regional interoperable communications projects and initiatives; and

WHEREAS, the City and County of San Francisco is the Fiscal Agent for the FY 2010 UASI grant award and an agreement with the City and County of San Francisco is required for the distribution, administration, and reimbursement of grant funds to the City of Oakland; and

WHEREAS, the grant funds will provide funding of up to \$610,708 for four (4) full-time equivalent (FTE) positions for the Oakland Fire Department's Office of Emergency Services, for the FY 2010 UASI grant period of July 1, 2011 through June 30, 2012, or until funding is exhausted; and

WHEREAS, the Homeland Security unit staffing is essential to ensure that Oakland is prepared for major terrorist incidents and natural disasters as well as to support the regional planning efforts and functions; and

WHEREAS, the FY 2010 UASI grant will provide a grant subsidy of \$8,292 for an existing Accountant III position in the Oakland Fire Department, Fire Administration that will spend 5% of their time as a Resource Planner for the FY 2010 SUASi grant program to assist in maximizing resources, budget and human capital; and

WHEREAS, Central Services Overhead (CSO) fees in the amount of twenty-seven thousand dollars (\$27,000) should be waived for the positions and any contract services that will be funded under this grant to ensure funding availability for grant expenses and to meet local grant concessions; and

WHEREAS, the grant designates that the amount of \$595,000 be expended for the purchase of specified equipment, supplies and contracted services identified on the Federally Authorized Equipment List ("AEL"); and

WHEREAS, some expenditures on the approved 2010 UASI spending plan may exceed the City Administrator's purchasing authority, which is \$100,000.00, \$50,000.00 or \$15,000.00 depending on the type of product or service under Oakland's Purchasing Ordinance, Oakland Municipal Code section 2.04.020; and

WHEREAS, staff recommends that the City Administrator be authorized to make all purchases identified on the 2010 UASI spending plan without further review or action by the City Council provided all such purchases are done in accordance with federal and City purchasing requirements, policies and programs; and

WHEREAS, ongoing costs, such as maintenance for equipment or goods purchased with the 2010 UASI grant will be absorbed by each respective City of Oakland agency's existing budget with no additional General Purpose Fund appropriation; and

WHEREAS, the City of Oakland is committed to cooperating with our regional partners to detect, prevent, prepare for, respond to, and recover from human-caused and natural disasters and to effectively carry out the programs of the FY 2010 UASI grant and to sustain programs made with previous years' UASI grants; now, therefore be it

RESOLVED: That the City Council authorizes the City Administrator or his designee to enter into the Bay Area Urban Area Security Initiative (UASI) Approval Authority Governance Memorandum of Understanding and Administration Agreement with the City and County of San Francisco for one million two hundred and twenty-five thousand dollars (\$1,225,000) in FY 2010 UASI Grant funds; and be it

FURTHER RESOLVED: That the City Administrator or his designee is authorized to accept and appropriate said FY 2010 UASI Grant funds into U.S. Department of Homeland Security Fund (2123), Office of Emergency Services Organization (20711), a grant project to be determined, and Office of Emergency Services/Homeland Security Program (PS21), with the full grant fund will being appropriated to the Miscellaneous Federal Grants Revenue Account (46129); and be it

FURTHER RESOLVED: That the City Administrator or his designee is authorized to approve the preliminary spending plan and that the spending plan includes allocations for four (4) full-time equivalent (FTE) positions, an offset for one Accountant III position, and for the UASI for the 2010 grant period July 1, 2011 through June 30, 2012, or until the grant funding is exhausted; and be it

FURTHER RESOLVED: That City of Oakland Central Services Overhead fees in the amount of \$27,000 are hereby waived for the US Department of Homeland Security Fund 2123 to ensure availability for grant expenses and to meet local grant guidelines; and be it

FURTHER RESOLVED: That the City of Oakland administrative fees such as central stores and contract assessment fees are hereby waived for the US Department of Homeland Security Fund 2123 to ensure availability for grant expenses and to meet local grant guidelines; and be it

FURTHER RESOLVED: That ongoing costs, such as maintenance for equipment or goods purchased with the FY 2010 UASI grant will be absorbed in each of the respective City of Oakland agencies' existing budget with no additional General Purpose Fund appropriation; and

FURTHER RESOLVED: That the City Administrator is authorized to make all purchases of equipment and services identified on the approved 2010 UASI spending plan without further review or action by the City Council, including purchases that exceed the City Administrator's purchasing authority under Oakland Municipal Code section 2.04.020, provided all such purchases are done in accordance with federal and City purchasing requirements, policies, and programs; and be it

FURTHER RESOLVED: That all contracts authorized hereunder shall be approved for form and legality by the Office of the City Attorney and placed on file in the Office of the City Clerk.
