## RESOLUTION PROCLAIMING THE WEEK OF MAY 7 TO MAY 16, 2010, AFFORDABLE HOUSING WEEK IN THE CITY OF OAKLAND

WHEREAS, East Bay Housing Organizations (EBHO) has organized Affordable Housing Week with over a dozen events to acknowledge the need for and contributions of affordable housing; now, therefore, be it
