A Report and Proposed Resolution Authorizing the City Administrator, on Behalf of the City of Oakland, to 1) Accept and Appropriate Grant Funds in an Amount Not to Exceed Five Hundred Thousand Dollars (\$500,000) From the U.S. Department of Justice, Office of Community Oriented Policing Services (USDOJ/COPS), FY 2009 Technology Program (COPS TECH) in Support of the Data Driven Approaches to Crime and Traffic Safety (DDACTS) Program in the Police Department, and 2) A Proposed Resolution Authorizing the Acceptance and Appropriation of Grant Funds in the Amount of Sixty-Six Thousand Nine Hundred and Two Dollars (\$66,902) From the U.S. Department of Transportation, National Highway Traffic Safety Administration, Also in

SUMMARY

A resolution has been prepared authorizing the City Administrator, on behalf of the City of Oakland to accept and appropriate grant funds in an amount not to exceed \$500,000 from the U.S. Department of Justice, Office of Community Oriented Policing Services (USDOJ/COPS), FY 2009 Technology Program (COPS TECH), in support of the Data Driven Approaches to Crime and Traffic Safety (DDACTS) program. An additional resolution is requested which authorizes the City Administrator, on behalf of the City of Oakland, to accept grant funds in the amount of \$66,902 from the U.S. Department of Transportation, National Highway Traffic Safety Administration (NHTSA), also in support of the Police Department's enactment of the DDACTS initiative.

The proposed program period for the COPS TECH program is October 1, 2009 through September 30, 2010. The proposed program period for the NHTSA sponsored program is October 1, 2009 through March 10, 2011. Funds from both sources will be used to provide supplemental law enforcement services and other innovative strategies to reduce the number of persons killed and injured in traffic collisions in the City of Oakland.

FISCAL IMPACT

Authorizing these two (2) resolutions will allow the City to accept and appropriate grant funds in an amount not to exceed \$500,000 from the U.S. Department of Justice, Office of Community Oriented Policing Services, as well as \$66,902 from the U.S. Department of Transportation, National Highway Traffic Safety Administration, to the Police Department for enactment of the

DDACTS program. Revenues and appropriations from both sources will be allocated in the Federal Grant Fund (2999), Traffic Administration Division Org. (107510), Traffic Program (PS14), in a Project Account to be determined. There is no match requirement. The Traffic Operations Section Commander will be responsible for ensuring that the terms set forth in the grant agreements are met.

Use of Funds Statement

It should be noted that the \$500,000 in COPS TECH grant funds is being used exclusively for requisite hardware, software, and data integration associated with the development of the CompStat platform. The proposed use of the \$66,902 in grant funds from NHTSA for sworn overtime associated with the Data Driven Approaches to Crime and Traffic Safety program was mandated by the grantor.

BACKGROUND

Law enforcement executives prioritize competing demands for police services every day. The scope of these demands continues to expand, while operating costs increase and resources diminish. This conflict between available resources and priorities has been detrimental to traffic enforcement and crime prevention in the Oakland. A number of law enforcement agencies have developed strategies based on the confluence of traffic incidents and crime to address both issues through common interventions. These strategies translate accurate and timely local data into an effective and fluid action plan to reduce crime and crashes. Law enforcement agencies have found such strategies to be not only more efficient in addressing their range of needs, but also more effective in improving the overall quality of life throughout the communities they serve. Agencies also have discovered the benefits of using locally driven initiatives and integrated operations.

KEY ISSUES AND IMPACTS

The Data Driven Approaches to Crime and Traffic Safety (DDACTS) program integrates location-based crime and traffic data to establish effective and efficient methods for deploying law enforcement and other resources using geo-mapping to identify areas that have high incidents of crime and crashes. DDACTS also uses traffic enforcement strategies that play a role in fighting crime and reducing crashes and traffic violations.

PROGRAM DESCRIPTION

Drawing on the deterrent of highly visible traffic enforcement and the knowledge that crimes often involve the use of motor vehicles, the primary goal of implementing DDACTS is to reduce the incidents of crime, crashes, and traffic violations. To accomplish this goal, the Police Department's Information Technology Division and Crime Analysis Unit shall work collaboratively with the OPD's Special Operations Unit - Traffic Enforcement Division's sworn personnel to not only monitor the levels of traffic-related crime throughout Oakland, but to proactively identify crime suppression opportunities.

October 27, 2009 The Crime Analysis Unit will be responsible for the coding of crime data entered through a computerized reporting system; responding to both internal and external requests for statistical data, and conducting strategic, administrative, and tactical analysis of crime data. With the technological assistance and guidance of the City of Oakland's Information Technology Division, the Crime Analysis Unit will use computer technology to compile and analyze crime data, inclusive of the utilization of a Geographic Information System for crime mapping.

CompStat Interface

To further enhance the DDACT program's purpose area(s), the data gathered will be linked to OPD's CompStat (COMPuter analysis of crime STATistics) process. The Police Department currently uses Integrated Public Safety System (IPSS) hardware and software applications, which are capable of providing crime statistics, crime maps, and various reports. DDACTS funds will provide dedicated technological and crime analysis functions, as well as additional software and hardware that will be an integral part of the CompStat platform that will allow for true-time, information-led policing. The new applications and software will provide added functionality that does not exist in the current public safety hardware and software infrastructure. This new functionality will allow disparate database integration, sophisticated link analysis, and web-based enterprise reporting and crime alerting.

SUSTAINABLE OPPORTUNITIES

Economic

Reckless driving, exhibitions of speed, unlicensed operation of a motor vehicle, DUI, and other traffic problems negatively impact property values and business opportunities. Efforts to address these problems will lead to improvements of these public safety issues.

Environmental

The toxic fumes produced by vehicles during sideshows and street racing are a health hazard. Abating the problems will result in an improvement in air quality.

Social Equity

The Police Department's traffic enforcement efforts are focused on those who do not obey traffic safety regulations and are more likely to cause or be involved in a traffic accident.

DISABILITY AND SENIOR CITIZEN ACCESS

There are no ADA or senior citizen access issues contained in this report.
