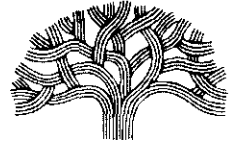

MEASURE O

Measure amending the Charter of the City of Oakland to require use of ranked choice voting known sometimes as instant runoff voting, to elect city offices by a majority vote at a November election without holding a prior June election

FURTHER RESOLVED, determined and declared the canvass of the returns of said General Municipal Election that the total number of ballots cast at the General Municipal Election was **110,006** (60.23%) and it is

FURTHER RESOLVED, that the City Clerk is hereby ordered to issue certificates of election to all persons herein declared elected; AND IT IS

FURTHER RESOLVED, that this Council orders and declares that the Official Canvass Summary report on file in the Office of the City Clerk, containing within the number of votes cast at each precinct for each candidate and for and against each measure, be and is hereby adopted.
