RESOLUTION NO. 91004 C.M.S.

**RESOLUTION AUTHORIZING THE CITY ADMINISTRATOR TO ACCEPT AND APPROPRIATE THE FISCAL YEARS 2024 AND 2025 STATE OF CALIFORNIA "CITIZENS OPTIONS FOR PUBLIC SAFETY" FOR:**

- 1) (STATE COPS GRANT XXVI) ALLOCATION IN THE AMOUNT OF EIGHT HUNDRED FIFTY-ONE THOUSAND SEVENTY-TWO DOLLARS (\$851,072) TO FUND HELICOPTER MAINTENANCE, COMPUTER/TECHNOLOGY UPGRADES, MARKETING SUPPLIES, WORKFORCE SUPPLIES, ASSET MANAGEMENT, AND TECHNOLOGY/REFURBISHED WORKSTATIONS; AND
- 2) (STATE COPS GRANT XXVII) ALLOCATION IN THE AMOUNT OF FIVE HUNDRED TWENTY-NINE THOUSAND NINE HUNDRED THIRTY-SEVEN DOLLARS (\$529,937) TO FUND HELICOPTER MAINTENANCE, CRIME LAB EQUIPMENT UPGRADES, TRAINING, AND COMPUTER/TECHNOLOGY UPGRADES

**WHEREAS**, the State Legislature estimated that funds in the amount of eight hundred fifty-one thousand seventy-two dollars (\$851,072) would be allocated in "pass-through" funding for the "Citizens Options for Public Safety" (State COPS Grant XXVI) which will be distributed to Alameda County and then transferred to the City of Oakland Police Department (OPD); and the State Legislature estimated that funds in the amount of five hundred twenty-nine thousand nine hundred thirty-seven dollar (\$529,937) would be allocated in "pass-through" funding for the "Citizens Options for Public Safety" (State COPS Grant XXVII) which will be distributed to Alameda County and then transferred to the City of Oakland Police Department (OPD); and

**WHEREAS**, funds must be used to support front-line police operations and must supplement, not supplant, existing police funding; and

**WHEREAS**, funds will be used to pay for helicopter maintenance, computer/technology upgrades, marketing supplies, workforce supplies, and asset management, helicopter maintenance, crime lab equipment upgrades, training, and technology/refurbished workstations; and

**WHEREAS**, the revenues and appropriations will be allocated to the State of California Grant Fund (2158); Fiscal Services Division Org (TBD); Agency-wide Administration Program (PS01), in a Project and Account to be determined; and

**WHEREAS**, in the past six years, the City Council has approved several resolutions to accept and appropriate State COPS Grants: Grant XXV via Resolution No. 89741 C.M.S., Grant XXIV via Resolution No. 88959 C.M.S., Grant XXIII via Resolution No. 88402 C.M.S., Grant XXII via Resolution No. 87938 C.M.S., Grant XXI via Resolution No. 87819 C.M.S., Grant XX via Resolution No. 87138 C.M.S., and Grant XIX via Resolution No. 86530 C.M.S.; therefore be it

**RESOLVED:** That the City Council authorizes the City Administrator or designee to accept and appropriate the State COPS Grant XXVI allocation in the amount of eight hundred fifty-one thousand seventy-two dollars (\$851,072); and be it

**RESOLVED:** That the City Council authorizes the City Administrator or designee to accept and appropriate the State COPS Grant XXVII allocation in the amount of five hundred twenty-nine thousand nine hundred thirty-seven dollars (\$529,937); and be it

**FURTHER RESOLVED:** That all contracts issued hereunder shall be reviewed and approved by the City Attorney for form and legality and copies shall be placed on file in the City Clerk's Office; and be it
