AN ORDINANCE AMENDING ORDINANCE NUMBER 12880 C.M.S. (MASTER FEE SCHEDULE), AS AMENDED, TO ESTABLISH A NEW FEE OF \$80.00 FOR ADULT **MONTHLY SWIM PASS** 

WHEREAS, the City of Oakland periodically updates its Master Fee Schedule to account for general cost of living increases and program changes or other costs; and

WHEREAS, the fee modifications and additions proposed herein have been justified by the respective agency and are identified in an "Agenda Report" dated July 21, 2009 entitled "An Ordinance Amending Ordinance Number 12880 C.M.S. (Master Fee Schedule), As Amended, To Establish A New Fee Of \$80.00 For Adult Monthly Swim Pass"; and

WHEREAS, the City Council finds and determines that the herein-referenced modifications and additions are necessary to reimburse the City for the costs of providing aquatic recreation; and

WHEREAS, a public meeting was held on July 21, 2009, to review the proposed fee changes; now, therefore

## THE COUNCIL OF THE CITY OF OAKLAND DOES ORDAIN AS FOLLOWS:

Section 1. The Master Fee Schedule as set forth in Ordinance Number 12880 C.M.S., as amended, is hereby amended to establish a new fee of \$80.00 for Adult Monthly Swim Pass, as set forth in Attachment A, attached hereto and made a part hereof.

Section 2. This ordinance shall be effective immediately if upon final passage it passes with six or more affirmative votes. It will take effect seven days after final passage if the ordinance passes with five affirmative votes
