RESOLUTION CONFIRMING THE INFORMATION IN THE ANNUAL REPORT FOR THE CITY OF OAKLAND WILDFIRE PREVENTION ASSESSMENT DISTRICT FOR FISCAL YEAR 2007-08 AND LEVYING OF THE ASSESSMENTS

WHEREAS, the City of Oakland Wildfire Prevention Assessment District (WPAD) was established on January 20, 2004 under the authority of the Oakland Fire Suppression, Prevention and Preparedness District Ordinance of 2003 (Ordinance No.12556 C.M.S.); and

WHEREAS, pursuant to the Oakland Fire Suppression, Prevention and Preparedness District Ordinance of 2003 (Ordinance No.12556 C.M.S.) on April 3, 2007, the City Council adopted the resolution initiating the FY 2007-08 assessment process for the City of Oakland Wildfire Prevention Assessment District and authorizing the City Administrator to order an Annual Report; and

WHEREAS, pursuant to the Oakland Fire Suppression, Prevention and Preparedness District Ordinance of 2003 (Ordinance No.12556 C.M.S.) on May 15, 2007, the City Council adopted the resolution of intention (Resolution No. 80569 C.M.S.) and accepting the Fiscal Year 2007-08 Preliminary Annual Report for the City of Oakland Wildfire Prevention Assessment District and setting a date for a public hearing; and

WHEREAS, pursuant to the Oakland Fire Suppression, Prevention and Preparedness District Ordinance of 2003 (Ordinance No.12556 C.M.S.) the City Administrator has filed with the City Clerk and presented before the City Council, on June 19, 2007, reports for the continuation of the District in order to finance the costs and expenses related to fire suppression, prevention and preparedness services and programs in the Oakland hills; and

WHEREAS, all the area of land to be assessed is located within the City of Oakland, Alameda County; and

WHEREAS, assessment rates will not exceed the rates established in FY 2004-05; and

WHEREAS, Tuesday, June 19, 2007, at the hour of 7:00 p.m., was fixed and properly noticed as the day and hour for the City Council to hear and pass on said reports; now, therefore be it

RESOLVED: That the City Council accepts and confirms the Annual Report filed with the City Clerk and scheduled before the City Council on June 19, 2007, for the continuation of the Wildfire Prevention Assessment District; and the diagram and assessment as set forth in the Final Annual Report for FY 2007-08 and each component part of it, including each exhibit incorporated by reference in the report; and be it

FURTHER RESOLVED: That the City Council confirms the levying of each individual assessment for FY 2007-08 as stated in the Assessment Roll prepared by the District Engineer; and be it

FURTHER RESOLVED: That the City Administrator is authorized to direct the District Engineer to present an itemized report of the FY 2007-08 Wildfire Prevention Assessment District assessments to the Auditor-Controller of the County of Alameda, State of California, to be placed on the FY 2007-08 property tax roll.
