I hold a Master of Public Policy degree from UC Berkeley, where I studied Oakland city governance and budget policy under former City Administrator Dan Lindheim. Professionally, I run a small climate policy consulting business that I co-founded with my past research advisor at UC Berkeley. In addition, I previously worked as a Legislative Aide for Berkeley City Councilmembers Lori Droste and as a Sustainability Analyst for San Francisco International Airport. I previously volunteered on Berkeley commissions, including eight years (six as Chair) on Berkeley's Environment and Climate Commission. I would be honored by the opportunity to serve on Oakland's Budget Advisory Commission. I know Oakland is facing unprecedented financial challenges. As a Budget Advisory Commissioner, I would dive into the City's budget data and work to understand it in detail and make it readily comprehensible and accessible to the public and City Councilmembers alike. I believe my detail-oriented and data-driven approach to policy would be an asset to the commission, and I'm excited to get further involved and help serve the community I now call home. ## RESOLUTION CONFIRMING THE MAYOR'S APPOINTMENT OF BEN GOULD TO THE BUDGET ADVISORY COMMISSION

**WHEREAS,** Section 601 of the City Charter provides that members of City boards and commissions shall be appointed by the Mayor subject to confirmation by the affirmative vote of five members of the City Council; and

**WHEREAS,** Ordinance No. 13337 C.M.S., adopted November 3, 2015, creates the Budget Advisory Commission to advise the Mayor and City Council on topics deemed important to the fiscal health of the City, encourage public participation and input into fiscal decision making, and improve the transparency and accountability of City fiscal information and decision making; and

**WHEREAS,** the Budget Advisory Commission shall be composed of 15 members appointed by the Mayor and confirmed by the Council in accordance with Section 601 of the City Charter; and

**WHEREAS,** members of the Budget Advisory Commission shall serve no more than two consecutive three-year terms plus any initial term of less than two years; and

**WHEREAS,** three members are selected by the Mayor, two members are recommended by the Chairperson of the Finance and Management Committee, one member is recommended by each Councilmember, one member is recommended by the City Auditor, and one member is recommended by the Chairperson of the Community and Economic Development Committee; and

**WHEREAS,** Councilmember Rowena Brown has recommended the appointment of Ben Gould to the Budget Advisory Commission; now, therefore, be it

**RESOLVED:** That the City Council hereby confirms the Mayor's appointment of the following individual to the Budget Advisory Commission as set forth below:
