EXECUTIVE SUMMARY

Attachment A to this report provides information on crime, crime trends, crime reduction and crime intervention activities in Oakland for the period of (3rd quarter of calendar year 2017). The 2nd Quarter Crime Report (April 1 through June 30, 2017) which was never presented to the Public Safety Committee, is also provided as **Attachment B**.

BACKGROUND AND LEGISLATIVE HISTORY

In 2013 the Public Safety Committee requested a quarterly report from OPD on crime trends and crime reduction activities in the City of Oakland. This report is provided four times a year and updated to include the preceding three-month period (January through March; April through June; July through September; and October through December).

This informational report is presented to the City Council and the Oakland community to provide an update on crime and crime reduction activities in Oakland. The attached presentation (**Attachment A**) contains information as follows:

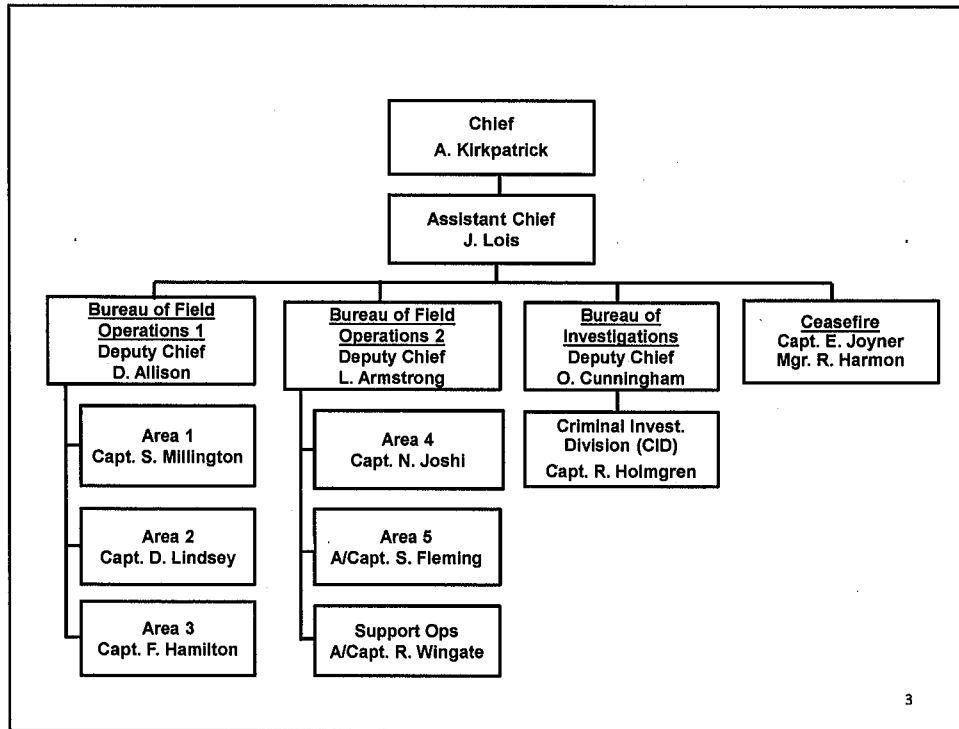

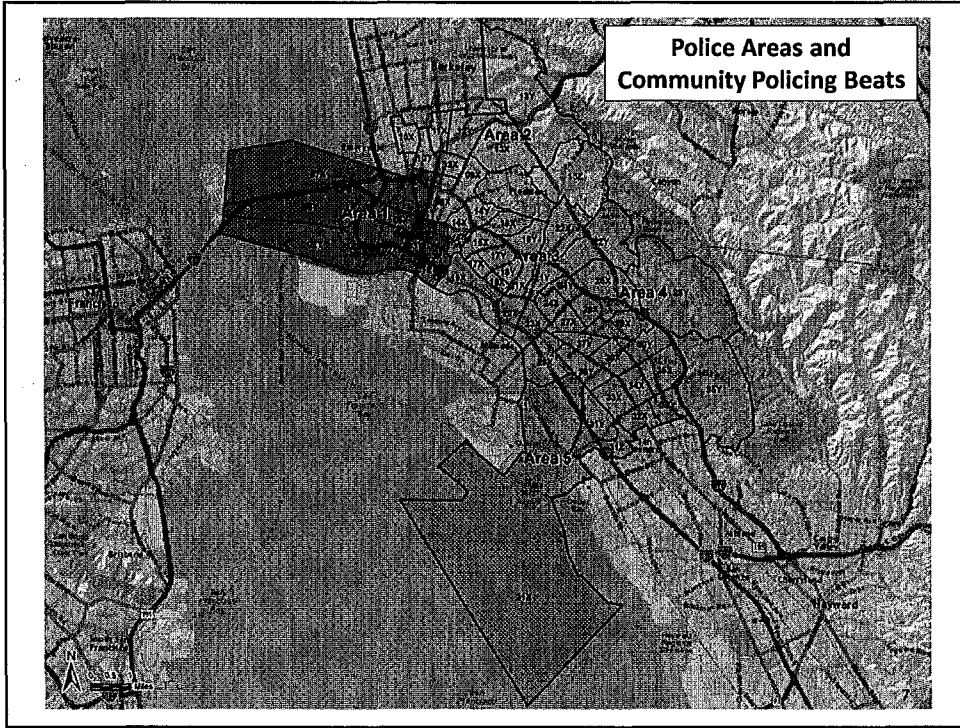

Area 4: Homicides

- There were nine homicides this year...down 25% for the quarter and 31% YTD
- Seven of nine homicides have been solved; arrests have been made 6 of these incidents
- Good investigative leads on the 2 other cases
- OPD has collaborated with the U.S. Marshals Service to locate the suspect connected to the fourth incident, as this suspect may no longer reside in Oakland

Area 4: Shootings Excluding Homicides

- Shootings are down 24% percent for this quarter and 22% YTD
- Most shootings are gang/group-related
- Custom notifications (as part of Ceasefire) issued to suspects
- Targeted and continuous enforcement on specific individuals, not neighborhoods

Area 4: Rapes

- No serial rapist; rapes not connected
- Most incidents involved suspects known to the victim
- Many incidents were domestic in nature
- Few incidents appear to be associated with prostitution

Area 4: Robberies

- Robberies are down 17% for this quarter and 12% YTD
- Dedicated foot patrols strategically deployed in high robbery areas
- Business districts are prone to robberies and auto burglaries
- Community outreach and education

Area 4: Robbery Trends

- Victims are typically on foot or getting in or out of a vehicle
- Juvenile groups committing multiple robberies
- Assailants physically searching victims during robberies
- Targeted Items:
 - Money
 - Cell phones
 - Jewelry
 - Electronics (laptops, notebooks, and so on)

Area 4: Robbery Trends

- Primary Areas:
 - Beat 23 (Fruitvale BART Station, Fruitvale Village, and surrounding areas)
 - Beat 24 (north of Foothill Blvd. between Fruitvale and High St.)
 - Beat 27
- Locations:
 - In front of residences
 - Entering/exiting vehicles
 - Sidewalks – talking on cell phones

- Burglaries, as a whole (residential, auto, other) are up 1% for this quarter and 5% YTD.
- Auto burglaries main reason for burglary increase.
- Residential burglaries are significantly down.

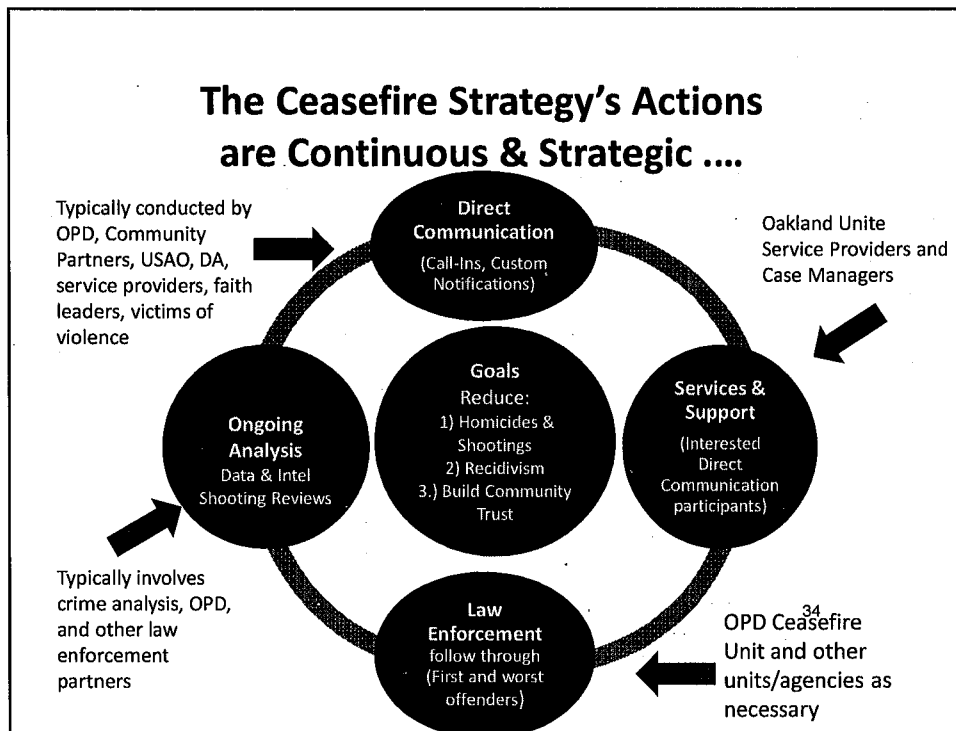

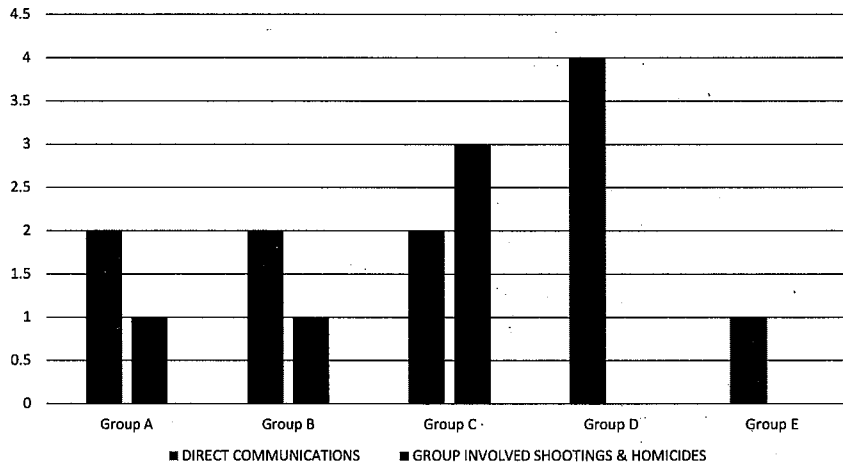

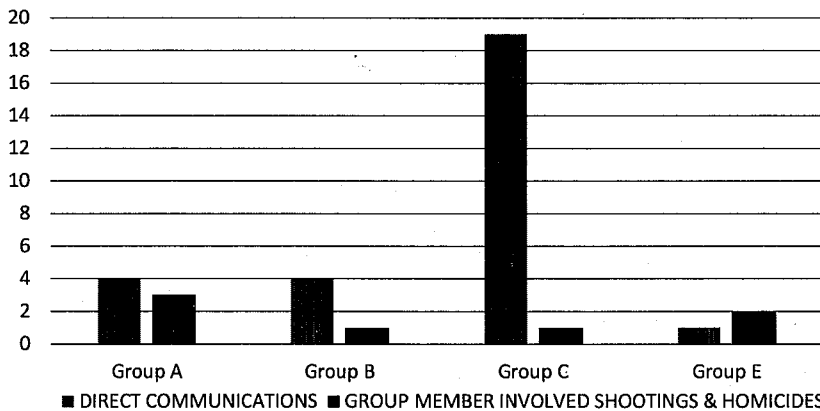

July 2017 Direct Communications & Top Group Member-Involved Shootings & Homicides*



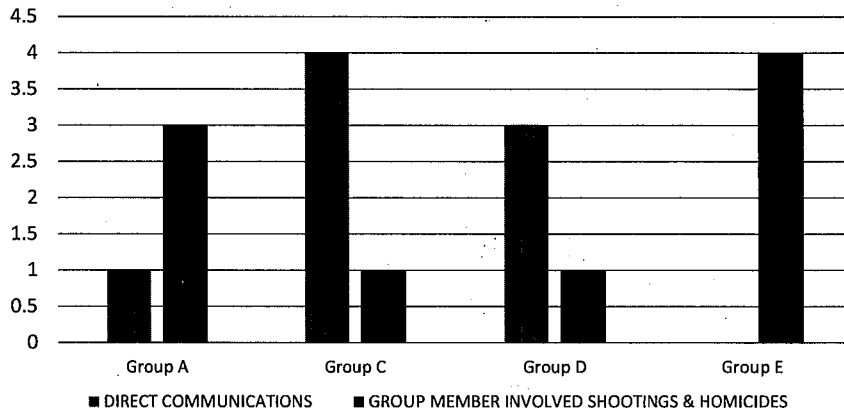

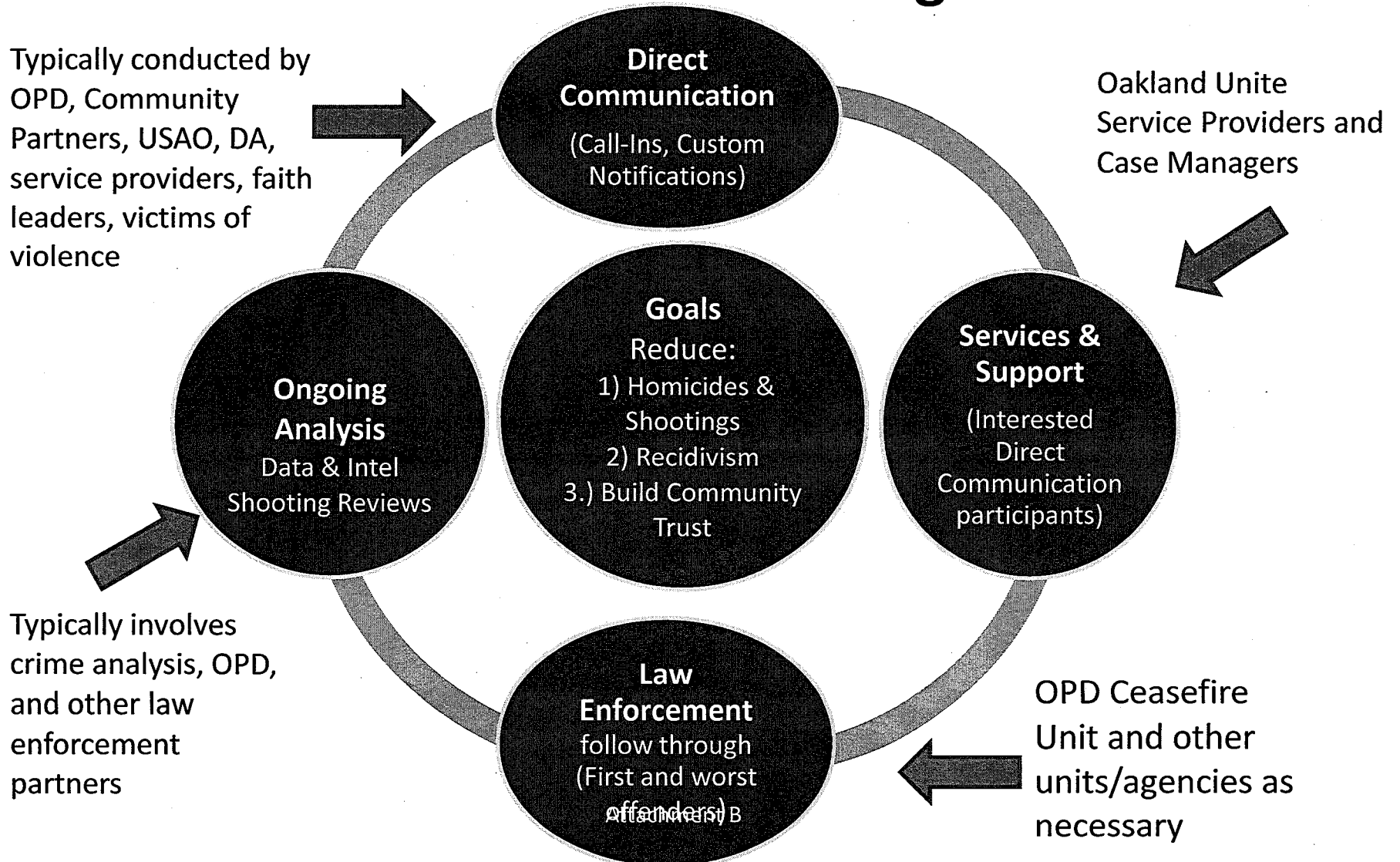

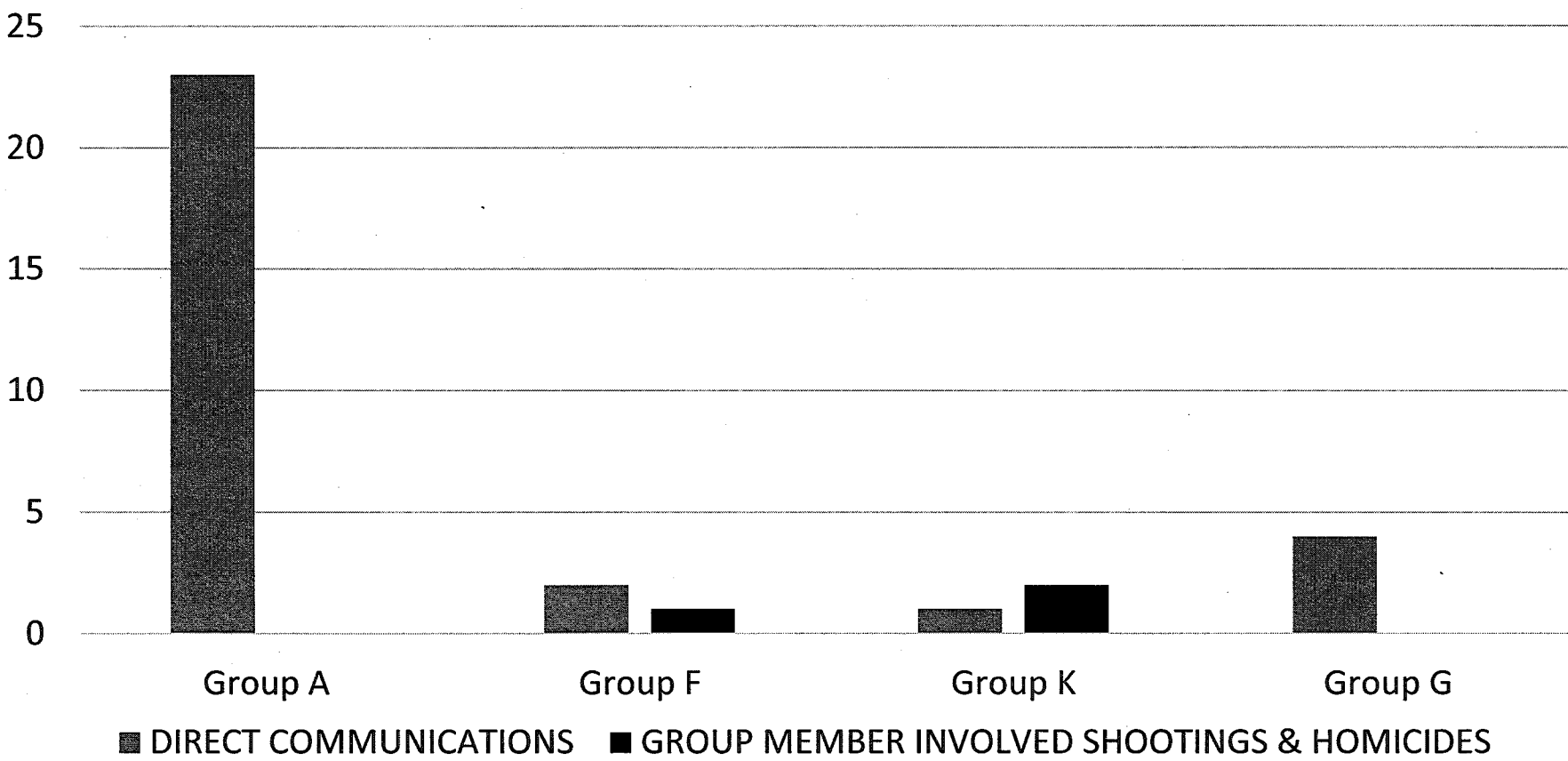

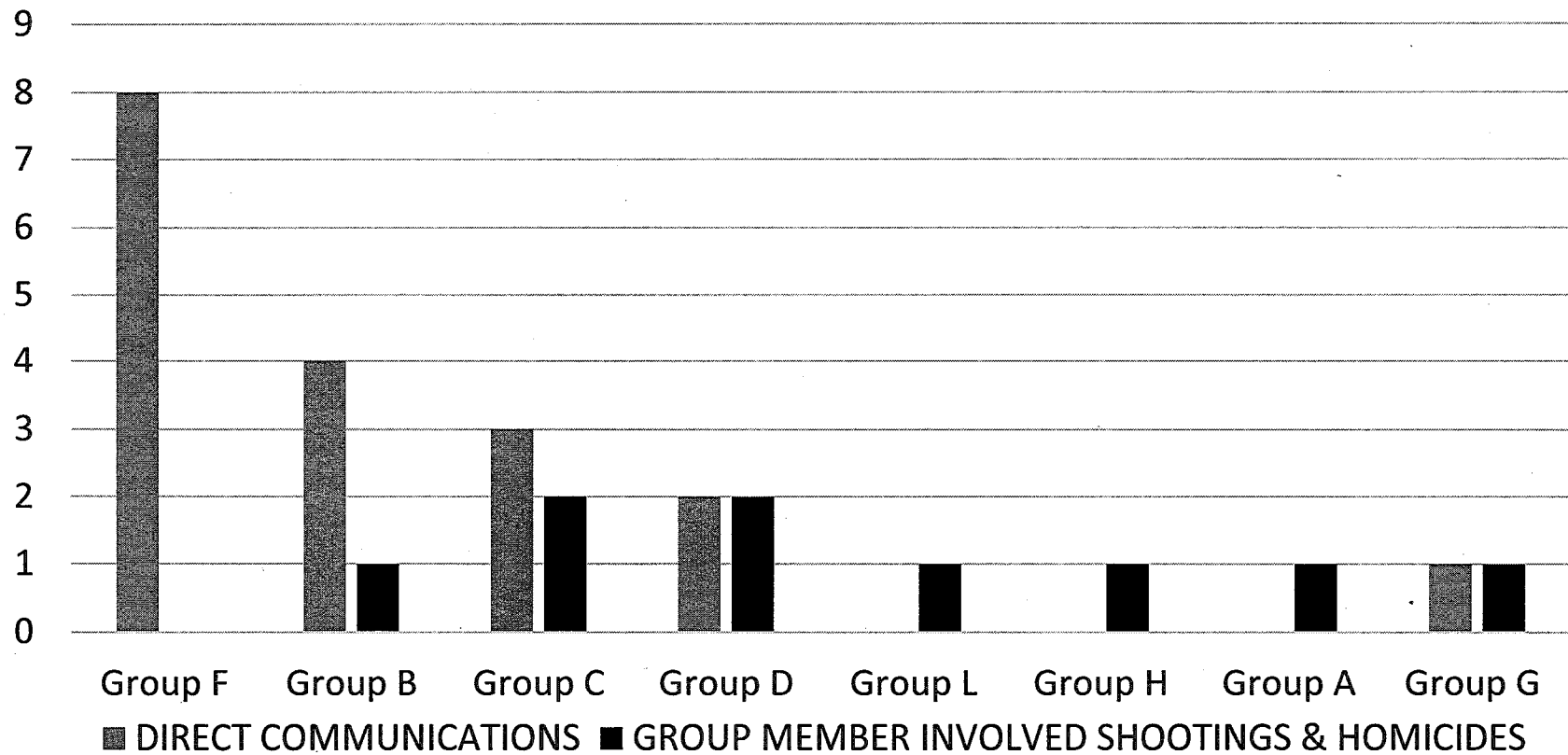

April 2017 Direct Communications & Top Group Member-Involved Shootings & Homicides*



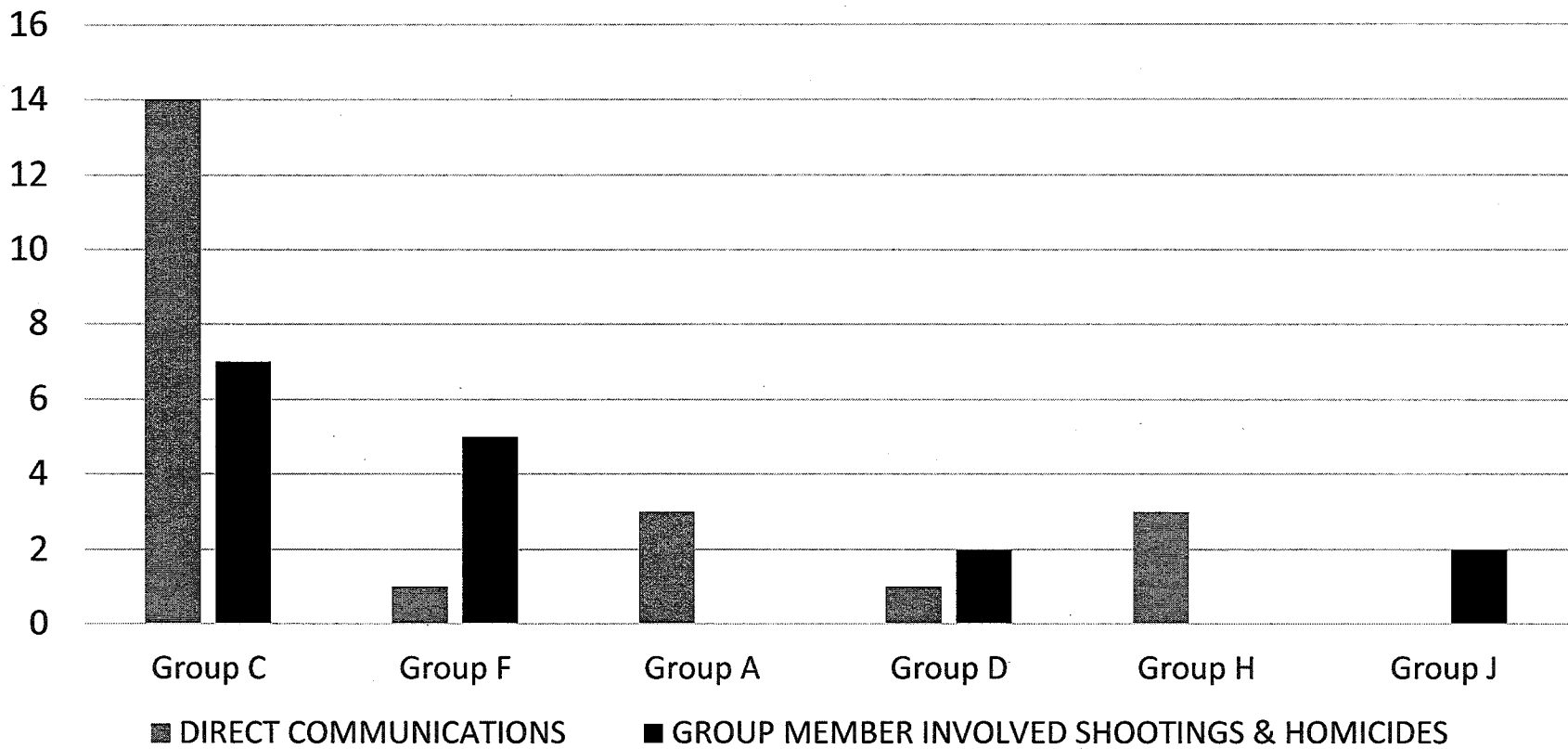

Next Steps for Evaluation

- Focus groups with Ceasefire-referred participants will take place in fall to better understand call-in and custom notification process
- Mathematica Policy Research working on the new overarching Measure Z evaluation
- First year evaluation will focus on life coaching and employment strategies, with analysis done by fall 2017
- Mathematica currently conducting evaluation site visits with agencies, which include staff and participant interviews
- Developed MOUs and data-sharing agreements to allow evaluator to confidentially match agency service data to OPD, OUSD, Probation data
- Evaluation report will examine one-year impacts of strategies in improving outcomes for participants (e.g. arrests, victimization, enrollment in school)
