RESOLUTION NO. 90653 C.M.S.

RESOLUTION AUTHORIZING THE CITY ADMINISTRATOR TO ACCEPT AND APPROPRIATE A GRANT AWARD IN THE AMOUNT OF ONE MILLION FOUR HUNDRED NINETY THREE THOUSAND ONE HUNDRED FORTY THREE DOLLARS (\$1,493,143) FROM THE STATE OF CALIFORNIA OFFICE OF ATTORNEY GENERAL, FOR FISCAL YEAR 2024-2028, FOR THE IMPLEMENTATION OF THE OAKLAND POLICE DEPARTMENT PROPOSITION 56 TOBACCO GRANT PROGRAM; AND AUTHORIZING THE CITY'S GENERAL PURPOSE FUND TO CONTRIBUTE ONE HUNDRED EIGHTY-SIX THOUSAND NINE HUNDRED NINETY FIVE DOLLARS (\$186,995) TO COVER ASSOCIATED CENTRAL SERVICES OVERHEAD COSTS.

WHEREAS, it is anticipated that grant funds in an amount not to exceed one million four hundred ninety-three thousand one hundred forty three dollars (\$1,493,143) will be received from the State of California, Department of Justice Office of the Attorney General for the implementation of the Prop 56 grant (DOJ-PROP56-2024-25-1-048) within the Police Department for the fiscal years 2024–2028; and

WHEREAS, these State of California DOJ Prop 56 grant funds are to be used to target retailers for illegal sales and marketing of tobacco products through law enforcement efforts combined with code enforcement efforts and the flavored tobacco ban will be enforced along with a comprehensive tobacco education program for merchants, Police Officers, and Code Inspectors within the City of Oakland; and

WHEREAS, the Police Department's and Economic primary goals through the DOJ Prop 56 Tobacco Grant is to reduce the illegal sales and possession of tobacco products to minors, prevent and reduce the illegal sales of tobacco products at unlicensed establishments, educate merchants on responsible tobacco vending, educate Police Officers and Code Compliance Inspectors on tobacco laws and regulations; and

WHEREAS, the State of CA DOJ Prop 56 grant period of performance is from December 1, 2024 through June 30, 2028; and

WHEREAS, grant funds will be used to cover one full time Police Officer positions to cover enforcement and educational requirements of the grant; and

WHEREAS, overhead costs are excluded and not allowed by the grantor; and

WHEREAS, Central Service Overhead Costs are calculated at the rate of 13.06% of the grant for associated overhead; now, therefore be it

RESOLVED: That the City Council does hereby authorize the City Administrator to accept and appropriate a grant award in the amount not to exceed one million four hundred ninety-three thousand one hundred forty-three dollars (\$1,493,143) from the State of California, Department of Justice Office of Attorney General; and be it

FURTHER RESOLVED: That the grant revenues from the State of California, Office of Attorney General, will be allocated to the Fund (TBD); Special Operations Division Org (107710); Project (TBD); Special Operations Program (TBD); and be it

FURTHER RESOLVED: That the City Council authorizes a contribution of \$186,995 from the general purpose fund to cover the associated Central Services Overhead; and be it

FURTHER RESOLVED: That the CSO funding will be allocated to State of California Fund (1010); Special Operations Division Org (107710); Project (TBD); Special Operations Program (TBD); and be it
