

**RESOLUTION REAPPOINTING DALE GIERINGER, SIERRA MARTINEZ, JAMES ANTHONY, MATT HUMMEL, JAKE SASSAMEN, A. KATHRYN PARKER AND AMANDA REIMAN TO THE COMMUNITY OVERSIGHT COMMITTEE FOR OVERSIGHT OF IMPLEMENTATION OF MEASURE Z, THE OAKLAND CANNABIS REGULATION, ORDINANCE NO. 12694 C.M.S., APPROVED BY VOTERS IN NOVEMBER 2004**

**WHEREAS**, Section 601 of the City Charter provides that members, of City boards and commissions shall be appointed by the Mayor subject to confirmation by the affirmative vote of five members of the City Council; and

**WHEREAS**, the Oakland Cannabis Regulation and Revenue Act (Ordinance 12694 C.M.S.), also known as Measure Z, adopted by the voters of Oakland, November 2, 2004 in the General Municipal Election, creates the Community Oversight Committee to make recommendations to the Council regarding implementation of the ordinance and recommendations for related policies; and

**WHEREAS**, the Oakland Cannabis Regulation and Revenue Act specifies that members of the Community Oversight Committee are to be appointed one by the Mayor, one by each Member of the City Council, and one member each shall be appointed to represent the City Administrator and the City Auditor, to serve unlimited two-year terms; and

**WHEREAS**, the Honorable Mayor Libby Schaaf has reappointed members as follows:

- Dale Gieringer as the District 1 Representative, as recommended by Councilmember Dan Kalb,
- Sierra Martinez as the District 3 Representative, as recommended by Council President Lynette Gibson McElhaney,
- James Anthony as the District 4 representative, as recommended by Councilmember Annie Campbell-Washington,
- Matt Hummel as the District 5 Representative as recommended by Councilmember Noel Gallo,
- Jake Sassaman as the District 7 Representative as recommended by Councilmember Larry Reid,

- A. Kathryn Parker as the At Large Representative as recommended by Councilmember Rebecca Kaplan, and
- Amanda Reiman as the City Auditor Representative as recommended by City Auditor Brenda Roberts,

to serve a two-year terms subject to confirmation by the City Council; now therefore, be it

**RESOLVED**, That pursuant to City Charter section 601, the City Council confirms the Mayor's reappointments as follows:

- Dale Gieringer as the District 1 Representative for two-year term beginning August 1, 2015 and ending July 31, 2017, previously held by herself,
- Sierra Martinez as the District 3 Representative for a two-year term beginning August 1, 2015 ending July 31 2017, previously held by herself,
- James Anthony as the District 4 Representative for a two year term beginning August 1, 2015 ending July 31, 2017, previously held by himself,
- Matt Hummel as the District 5 Representative for a two-year term beginning August 1, 2015 ending July 31, 2017, previously held by himself,
- Jake Sassaman as the District 7 Representative for a two-year term beginning August 1, 2015 and ending July 31, 2017, previously held by himself,
- A. Kathryn Parker as the At-Large Representative for a two- year term beginning August 1, 2015 and ending July 31, 2017,, previously held by herself, and
- Amanda Reiman as the City Auditor Representative for a two-year term beginning August 1, 2015 and ending July 31, 2017,, previously held by herself.


