INTRODUCED BY COUNCILMEMBER CARROLL FIFE

RESOLUTION DECLARING MAY 15, 2025 AS BIKE TO WHEREVER DAY IN THE CITY OF OAKLAND

WHEREAS, Bicycling is a healthy, affordable, environmentally - friendly way for Oaklanders to get around, and Whereas Oakland is a top city in the US for bicycling - now a Gold level Bicycle Friendly Community; and

WHEREAS, the safety of all road users increases as more people cycle and walk due to the 'safety in numbers' effect, and this is good for local businesses as more in Oakland shop by bike and on foot; and

WHEREAS, Walk Oakland Bike Oakland and Bike East Bay are two local advocacy organizations working to build support for redesigning our streets for people, celebrating that while Oakland has built more than two hundred miles of bike lanes, paths and boulevards, much work remains; and

WHEREAS, Oakland has benefitted from 30 years of community leadership through the Bicyclist and Pedestrian Advisory Committee and, eventually, the Bicyclist and Pedestrian Advisory Commission led by neighborhood leaders across the city, focusing on four goals:

1. Be strong advocates for bicyclist and pedestrian safety and hold the city accountable.
2. Be a two-way conduit for information on bicyclist and pedestrian projects.
3. Encourage equity-driven investments and policies and increase community involvement in high-injury and historically underserved areas.
4. Build relationships with policymakers and provide feedback on policies that affect walking and bicycling in Oakland; and

WHEREAS, Oakland’s Neighborhood Bike Route guide and Slow Streets implementation recommendations prioritize equitable access to calm, friendly streets for biking, walking, and playing from West Oakland to Deep East Oakland; and

WHEREAS, the City of Oakland integrates critical and free-of-charge bicycle repair and programming through its public libraries, such as the mobile free bike library and The Bike Fix at the 81st Avenue Library branch; and

WHEREAS, the Bay Wheels bike share program in Oakland, which launched in 2017, has since installed 83 docking stations with 650 pedal bicycles and 510 electric-assist bicycles, plus a planned expansion into new neighborhoods with another 19 stations to be added in 2025; and

WHEREAS, since 1999, the City of Oakland has installed over 3,000 bicycle parking racks and 420 publicly-accessible bicycle eLockers in the public right-of-way, in addition to supporting free valet bicycle parking facilities at Fruitvale BART and 19th Street Downtown; and

WHEREAS, every transit system serving Oakland (BART, AC Transit, Amtrak Capitol Corridor, SF Bay Ferry, and more) provides access for bicycles and e-bikes at no additional charge, and BART allows bicycles on escalators and on-board trains at all hours; and

WHEREAS, the City of Oakland has adopted high quality bicycling infrastructure such as the physically separated bikeways completed on Telegraph Ave, Lakeside Dr., and Broadway, and is at work on similar facilities in 2025 on Fruitvale Ave, Harrison St, 14th St, 20th St, Lakeshore Ave, Doolittle Dr. and more, in addition to new multi-use trails along San Leandro St and the San Leandro Creek; and

WHEREAS, Rick Rickard is named Bike Commuter of the Year (BCOY) for his decades of commitment to biking in Oakland and the East Bay; and

WHEREAS, Bike to Wherever Day is an annual event, now in its 32nd year in Oakland that encourages people to try cycling around town; and

WHEREAS, on the morning of Bike to Wherever Day, dozens of energizer stations will be set up around Oakland with drinks, snacks, and the iconic bike bag for those bicycling until supplies run out, with a free breakfast at City Hall for bicyclists riding in “Pedal Pools” with Elected Officials, as well as a Bike Happy Hour gathering from 4-7pm in Old Oakland; now, therefore, be it


