RESOLUTION AUTHORIZING THE CITY ADMINISTRATOR, ON BEHALF OF THE CITY OF OAKLAND, TO APPLY FOR, ACCEPT AND APPROPRIATE THE CHILD CARE FOOD PROGRAM (CCFP) GRANT FROM THE CALIFORNIA DEPARTMENT OF EDUCATION IN AN ESTIMATED AMOUNT OF \$360,000 FOR PROGRAM YEAR 2004-2005

WHEREAS, the City of Oakland desires to apply for, accept and appropriate a Child Care Food Program (CCFP) Grant in an estimated amount of \$360,000 from the California Department of Education to fund a Head Start child nutrition program from September 1, 2004 through August 31, 2005; and

WHEREAS, the adopted policy budget for FY 2004-2005 includes the grant at \$360,000 and;

WHEREAS, the California Department of Education Child Nutrition and Distribution Division will provide funds for comprehensive nutrition services to one thousand, one hundred and sixty-three (1,163) Head Start children, who have the most economic need, with 10% of the enrollment consisting of children with special needs; and

WHEREAS, the City wishes to apply for, accept and appropriate the Child Care Food Program (CCFP) grant from the Department of Education in an estimated amount of \$360,000 for Head Start nutrition services; now, therefore, be it

RESOLVED: That the City Administrator or his designee as agent of the City of Oakland is hereby authorized and directed to submit on behalf of the City of Oakland an application to CCFP for funds to operate a Child Care Food Program for Children in the City of Oakland from September 1, 2004 through August 31, 2005 and to execute and submit all documents, including but not limited to agreements, amendments, and payment requests which may be necessary to obtain funds to operate such a program and to accept said funds; and, be it further

RESOLVED: That the City Administrator is hereby authorized and directed to appropriate any additional funding which may become available from this grant; and be it further

RESOLVED: That the sum of \$360,000 and offsetting revenue shall be appropriated to Fund 2128, Organization 78231, Project G226010 for the purpose of operating the Child Care Food Program.
