The L/SLBE program requires that there must be at least three certified businesses listed in the industry, trade or profession that constitutes a major category of work. If at least three L/SLBEs are not certified, then the requirement is either waved or the 50% requirement may be set from 50% to 0%. There were no certified firms that could perform the scope of work; therefore, the minimum 50% Local/Small Local Business Enterprise participation requirement waived for this project.
