RESOLUTION AUTHORIZING A CONTRACT WITH KIMLEY-HORN AND ASSOCIATES FOR DESIGN SERVICES FOR THE INTELLIGENT TRANSPORTATION SYSTEMS (ITS) DEPLOYMENT IN THE OAKLAND AIRPORT-COLISEUM AREA (PROJECT #G162010) FOR AN AMOUNT NOT TO EXCEED TWO HUNDRED FORTY-TWO THOUSAND ONE **HUNDRED NINETY-FIVE DOLLARS (\$242,195)** 

WHEREAS, the City intends to conduct engineering design for the Intelligent Transportation Systems (ITS) deployment in the Oakland Airport-Coliseum area; and

WHEREAS, a total funding amount of \$300,000 in state grants and Measure B monies is available and appropriated to the project accounts for the proposed scope of work, including staff oversight and consulting services; and

WHEREAS, the Public Works Agency issued a Request for Proposals soliciting proposals from qualified consultants to develop a comprehensive ITS Deployment plan with the goals of improving traffic flow and enhancing air quality by reducing congestion in the area; and

WHEREAS, the firm of Kimley-Horn and Associates was selected as the most qualified firm to provide the identified consulting services for this project; and

WHEREAS, the City Council finds that the services provided pursuant to the agreement authorized hereunder are of a professional, scientific, or technical nature and are temporary in nature; and

WHEREAS, Council finds that this contract shall not result in the loss of employment or salary by any person having permanent status in the competitive service; now, therefore, be it

**RESOLVED:** That the City Manager, or his authorized representative, is hereby authorized to enter into an agreement with Kimley-Horn and Associates to provide design services for the Intelligent Transportation Systems (ITS) deployment in the Oakland Airport-Coliseum area for an amount not to exceed \$242,195; and be it

**FURTHER RESOLVED:** That the City Manager, or his authorized representative, is hereby authorized to approve any subsequent amendments to or extensions of said agreement. provided that such amendments or extensions shall be filed with the Office of the City Clerk; and be it
