

RESOLUTION AUTHORIZING A GRANT USE OF \$4,591.96 from Councilmember Desley Brooks' Priority Project funds to PAY FOR TNT's Custom Screen PrintEDing to produce t-shirts PROMOTINGfor a City sponsored THE "SO YOU THINK YOU CAN HOOP" event ORGANIZED BY COUNCILMEMBER DESLEY BROOKS' OFFICE; and

WHEREAS, on June 8, 2006, the City Council did amend the 2005-2007 Policy Budget for the City of Oakland to include \$250,000 a piece for the Mayor and each councilmember to use as priority funds for projects in the City of Oakland or in council members' districts subject to City Council approval; and

WHEREAS, Councilmember Brooks wishes to <u>usegrant</u> a portion of her priority project funds to <u>pay for t-shirts produced by TNT's Custom Screen Printing thate promote a community youth event "So You Think You Can Hoop" organized by Councilmember Brooks' office-produce t-shirts for a City spensored event; and</u>

WHEREAS, the City will require TNT's Custom Screen Printing to provide documentation for use of the Councilmember's priority project funds; now, therefore, be it

RESOLVED: that the City Council authorizes the <u>use grant</u> of \$4,591.96 from Councilmember Brooks' priority project funds to <u>be paid to TNT's Custom Screen Printing to produce t-shirts for a <u>community youth event "So You Think You Can Hoop." City sponsored event; and, be it</u></u>

FURTHER RESOLVED: that the City Administrator is authorized to execute an appropriate grant agreement with TNT's Custom Screen Printing consistent with the purposes of the grant, subject to approval as to form and legality by the City Attorney.
