WHEREAS, the Youth Advisory Commission was created by Ordinance No.10545 C.M.S., adopted February 5, 1985, amended by Ordinance No. 11461, passed June 23, 1992, and amended by Ordinance No. 11869, passed March 12, 1996; and

WHEREAS, the Youth Advisory Commission is comprised of Twenty-Five youth from ages 13 to 21, appointed by the Mayor and Council, one to represent each Council District and the remaining eighteen to serve as at-large members, with all appointments being for a period of two years, with a limit of two consecutive terms; and

WHEREAS, the purpose of the Youth Advisory Commission is to identify the needs of youth of the community from the ages of 13 to 21, thereby creating citizen awareness of such needs and serving as the policy recommending body for civic/education-related matters within the jurisdiction of the City of Oakland in which youth have an interest, and
