RESOLUTION DECLARING THE RESULTS OF THE CITY OF OAKLAND SPECIAL MUNICIPAL ELECTION HELD ON TUESDAY, MARCH 5, 2024

WHEREAS, pursuant to California law and Section 1101 of the Charter of the City of Oakland, a Special Municipal Election was duly and regularly held in the City of Oakland on Tuesday, November 8, 2022; and

WHEREAS, the Alameda County Registrar of Voters has prepared and submitted a certified statement of the results of said Special Municipal Election; and

WHEREAS, the City Clerk has canvassed the election returns of said Special Municipal Election pursuant to law; and

WHEREAS, the City Clerk has certified the results for the Special Municipal Election attached hereto as **Exhibit A**; and

WHEREAS, California Elections Code sections 10263 and 15400 provide that the governing body shall declare the results of each election under its jurisdiction as to the persons elected and the measures voted on at the election; now, therefore, be it

Measure increasing the appropriations limit under Article XIII B of the California Constitution (which limits city expenditures of tax proceeds) to allow the City of Oakland to continue to expend revenues from taxes Oakland voters previously approved for emergency medical services, paramedic services, library services, public safety and violence prevention services, homeless services, children's services, parks and recreation, the Oakland Zoo and other lawful government purposes, without increasing or imposing new taxes.




