

RESOLUTION APPROVING AND AUTHORIZING THE EXECUTION OF SUPPLEMENT NO. 4 TO THE MASTER AGREEMENT AND EXHIBITS TO THE MASTER AGREEMENT BETWEEN THE OAKLAND RAIDERS AND THE OAKLAND ALAMEDA COUNTY COLISEUM AUTHORITY

WHEREAS, the Board of Commissioners of the Oakland Alameda County Coliseum Authority (the "Authority") has approved and authorized the execution of Supplement No. 4 ("Supplement 4") to the Master Agreement And Exhibits to the Master Agreement between the Oakland Raiders and the Oakland Alameda County Coliseum Authority ("the Master Agreement"); and

WHEREAS, execution of Supplement 4 is a modification of an existing license agreement entered into pursuant to the Master Agreement; and

WHEREAS, the Amended and Restated Management Agreement by and among City of Oakland, County of Alameda and Oakland-Alameda County Coliseum Authority requires approval by the City of Oakland ("City") and the County of Alameda ("County"), as joint owners of the Oakland-Alameda County Coliseum Complex, ("Coliseum Complex") of any modification to any existing license agreement pertaining to the Complex before such modification can be executed; and

WHEREAS, the Authority has requested and recommended that the City approve and authorize the execution of Supplement No. 4; and

WHEREAS, the accompanying staff report presented to this meeting, sets forth the terms and conditions of Supplement No. 4; and

WHEREAS, a form of the Supplement has been presented to this meeting as an attachment to the staff report; and

WHEREAS, staff has recommended that the City Council of the City of Oakland ("the City") approve and authorize the Authority to execute Supplement No. 4; and

WHEREAS, the City finds it advisable and now desires to approve the form of Supplement No. 4 and to authorize execution by the Authority of Supplement No. 4; and now, therefore, be it

RESOLVED: That all of the recitals above set forth are true and correct, and the City so finds and determines; and be it

FURTHER RESOLVED: That the City hereby approves and authorizes the execution Authority of Supplement No. 4, in substantially the form presented to this meeting with only those changes that the Authority Chair, with the advice of counsel to the Authority, shall approve; and be it

FURTHER RESOLVED: That the City Clerk is hereby authorized to attest, if required, Supplement No. 4; and be it

FURTHER RESOLVED: That all actions heretofore taken by the officers and agents of Authority concerning the negotiations pertaining to the agreement reached as reflected in Supplement No. 4 are hereby approved, confirmed and ratified, and the City recommends that the Authority direct and authorize its proper officers, for and in the name and on behalf of the Authority, to do any and all things and take any and all actions and necessary to execute Supplement No. 4, and other documents which they, or any of them, may deem necessary or advisable in order to effectuate the purposes of this resolution.


