

RESOLUTION No. 83877 C.M.S.

RESOLUTION APPOINTING RICHARD ZAVALA AS A MEMBER OF THE BUDGET ADVISORY COMMITTEE FOR THE TERM BEGINNING MAY 25, 2012 AND ENDING MAY 24, 2014

WHEREAS, Resolution No. 74826 C.M.S., adopted March 2, 1999, creates the Budget Advisory Committee to provide fiscal management in an advisory capacity to the City Council; and

WHEREAS, the Budget Advisory Committee consists of 15 members, one (1) to be appointed by each of the eight City Councilmembers, one (1) appointed by the Mayor to act as Chairperson, three (3) appointed by the Mayor from a list of 12 recommendations from the Chamber of Commerce, two (2) recommended by the Chairperson of the Finance and Management Committee, and one (1) recommended by the Chairperson of the Community and Economic Committee, each serving no more than two consecutive two-year terms and each subject to the approval of the City Council; and

WHEREAS, Section 601 of the City Charter states that if the Mayor does not submit for confirmation a candidate to fill a vacancy within 90 days of the date the vacancy first occurred, the Council may fill the vacancy; and

WHEREAS, District 1 representative Andrew Singer's term on the Budget Advisory Commission expired on May 24, 2010 and the Mayor has not submitted a candidate to fill this vacancy; and

WHEREAS, because more than 90 days have passed since the vacancy occurred, the City Council may now fill the vacancy; and

WHEREAS, Councilmember Jane Brunner has nominated Richard Zavala to fill the above vacancy; now, therefore, be it

RESOLVED: That the City Council hereby appoints Richard Zavala as the District 1 representative to for the term beginning May 25, 2012 and ending May 24, 2014, filling the District 1 Representative seat previously held by Andrew Singer.
