A RESOLUTION AUTHORIZING THE CITY ADMINISTRATOR TO:

1) ACCEPT AND APPROPRIATE THIRTY FIVE THOUSAND NINE HUNDRED SEVENTY- EIGHT DOLLARS AND TWENTY- EIGHT CENTS (\$35,978.28) FROM THE STATE OF CALIFORNIA OFFICE OF EMERGENCY SERVICES TO REIMBURSE THE CITY FOR TRAINING AND EQUIPMENT COSTS INCURRED BY THE OAKLAND FIRE DEPARTMENT URBAN SEARCH AND RESCUE (USAR) TEAM FOR A MOBILIZATION EXERCISE, AND

2) USE FEDERAL COMPETITIVE BIDDING PROCESSES FOR EQUIPMENT PURCHASES WHEN REQUIRED BY FEMA

WHEREAS, the Oakland Fire Department is the Sponsoring Agency for California Task Force 4 (CA TF4) Urban Search and Rescue (USAR); and

WHEREAS, CA TF4 is one of 8 California and 28 national USAR teams; and

WHEREAS, the Federal Emergency Management Agency (FEMA), a component of the Department of Homeland Security (DHS), is the federal management agency; and

WHEREAS, FEMA supports all 28 USAR teams with federal grants; and

WHEREAS, the State of California Office of Emergency Service is the agency under whose authority CATF4 operates within the State; and

WHEREAS, the State of California Office of Emergency Service has a Joint Powers Agreement with the County of Sacramento and FEMA Urban Search and Rescue; and

WHEREAS, CA TF4 has been issued \$35,978.28 from the County of Sacramento to reimburse CATF4 for expenses incurred during the City's annual mobilization drill; now, therefore, be it

RESOLVED: that the Oakland City Council, hereby authorizes the City Administrator to accept \$35,978.28 from the County of Sacramento to reimburse the City (CATF4) for expenses incurred during the annual CATF4 mobilization drill and to meet the continued expenses of the Oakland Fire Department's Urban Search and Rescue Team as they equip and train to respond to natural disasters or weapons of mass destruction; and, be it

FURTHER RESOLVED: that the funds shall be appropriated and deposited into the California State Emergency Services Fund (#2146), account number 46229, project to be

determined, and the special operation program number PS18, and the account numbers will be the actual expenditure accounts; and, be it

FURTHER RESOLVED: That the City Council finds and determines that it is in the City's best interests to use federal competitive bid processes required by FEMA for equipment purchases with said County of Sacramento funds, hereby waives Oakland's competitive bidding processes for such purchases pursuant to Oakland Municipal Code Section 2.04.050.I.5, and authorizes the City Administrator to make such equipment purchases using federal competitive processes, provided that such expenditures do not exceed the City Administrator's contract authority (i.e., \$250,000.00).
