RESOLUTION AUTHORIZING THE CITY MANAGER TO ACCEPT AND APPROPRIATE A GRANT FROM THE ALAMEDA COUNTY CHILDREN AND FAMILIES COMMISSION TO THE OAKLAND ELMHURST EVEN START FAMILY LITERACY PROGRAM, SERVING FAMILIES WITH CHILDREN FROM BIRTH TO AGE SEVEN, IN THE ESTIMATED AMOUNT OF \$150,000 FOR A TWO-YEAR PERIOD COMMENCING JULY 1, 2003, AND TO NEGOTIATE AND EXECUTE AN AGREEMENT WITH THE COUNTY OF ALAMEDA FOR THIS PROJECT.

WHEREAS, the Council has previously approved the establishment of the Oakland Elmhurst Even Start Family Literacy Program, serving families with children from birth to age seven; and

WHEREAS, the Oakland Elmhurst Even Start Family Literacy Program receives its basic funding from the U. S. Department of Education through the California Department of Education; and

WHEREAS, the federal funding for this project declines by ten percent per year for three years, and the Project needs to replace this lost revenue; and

WHEREAS, in April 2003 the Oakland Elmhurst Even Start Family Literacy Program applied for a grant from the Alameda County Children and Families Commission, which has advised the City that it wishes to fund the project; now, therefore be it

RESOLVED: That the City Manager is hereby authorized and directed to accept and appropriate a grant from the Alameda County Children and Families Commission for the Oakland Elmhurst Even Start Family Literacy Program, serving families with children from birth to age seven, in the estimated amount of \$150,000 for a two-year period commencing July 1. 2003; and be it further

RESOLVED: That, should additional funds be received, the City Manager or his designee is hereby authorized to appropriate same for the purposes described above; and, be it further

RESOLVED: That \$27,865 in General Purpose Funds are hereby authorized to offset central services, departmental, and divisional overhead charges in addition to those, in the amount of \$15,000, which will be recovered from the grant; and, be it further

**RESOLVED**: That the City Council hereby appoints the City Manager or his authorized representative as agent of the City to negotiate and to enter into an Agreement with the County of Alameda for the estimated amount specified, for the purposes stated, and to conduct all negotiations, execute and submit all documents, including but not limited to applications, agreements, amendments, modifications, payment requests, and related action which may be necessary in accordance with its basic purpose; and, be it further

**RESOLVED**: That copies of said grant awards and said contracts and Agreements will be approved by the City Attorney as to form and legality and will be on file with the City Clerk.
