Assistance Center to the Michael L. McPherson Oakland Business Assistance

Center

#### **SUMMARY**

Staff is requesting a public hearing and an approval from the City Council to rename the City of Oakland Business Assistance Center, located at 250 Frank H. Ogawa Plaza, to the Michael L. McPherson Business Assistance Center in honor of colleague, Michael L. McPherson. In accordance with Council policy regarding the naming of public facilities, a public hearing and City Council resolution are required.

#### FISCAL IMPACT

There is minimal fiscal impact involved with the proposed renaming. There is one large external sign and a large internal sign that would need to be replaced, and the name of the Business Assistance Center will need to be expanded on the main door. In addition, a "wall of honor" will be designed and installed. The approximate cost for all of these changes will not exceed \$10,000, and will be paid for with previously appropriated monies from Fund 9510. The Center's website will be updated online, and printed documents such as brochures and letterhead bearing the current name of the Business Assistance Center will be updated as they are depleted. Such changes will not incur additional costs to the City.

#### **BACKGROUND**

On June 21, 2011, the City Council and the leadership of the Community and Economic Development Agency proposed that the city rename the Oakland Business Assistance Center the Michael L. McPherson Oakland Business Assistance Center in honor of colleague, Michael L. McPherson. The Oakland City Council passed Resolution No. 83401 C.M.S. signaling this intention.

Since December 2007 Michael McPherson was a committed and enthusiastic City employee who was instrumental in the establishment of, and management of, the Oakland Business Assistance Center. Prior to working for the City, Michael McPherson assisted the community as a staff

member of OBDC, formerly the Oakland Business Development Corporation, for 25 years and ultimately became the Executive Director of OBDC for 15 years from May 1991 to August 2006.

On Thursday, September 29, 2011 Michael McPherson was posthumously recognized in honor of Small Business Month by the Oakland Merchants Leadership Forum "OMLF" for his successful work through the Oakland Business Assistance Center and for being a friend to Oakland Small Businesses.

Michael McPherson passed away on Tuesday, June 7, 2011 in Oakland and the renaming of the Oakland Business Assistance Center would memorialize the contributions of Michael McPherson to the City of Oakland and to the East Bay small business community.

#### PROJECT DESCRIPTION

The passing of this Resolution to rename the Business Assistance Center would entail the purchase of one or two new signs to be created and installed at the Business Assistance Center location. Minor formatting changes would be necessary on Business Assistance Center informational documents; however those can be handled in-house at no extra cost.

WHEREAS, there is redevelopment fimding available for new interior signs which is the only cost associated with the renaming action; and

WHEREAS, the City Council held a duly noticed public hearing on October 18, 2011 to consider the proposal; now, therefore,
