A Supplemental Report on the City's Progress in Preparing Projects for Funding and Identifying and Applying for Grants from the American Recovery and Reinvestment Act of 2009

SUMMARY

Councilmember Brunner requested the following information to be included in a supplemental report to the status report on the City's progress in preparing projects for funding and identifying and applying for grants from the American Recovery and Reinvestment Act of 2009 (ARRA).

FISCAL IMPACT

This is an informational report; therefore no fiscal impacts are included. Fiscal impacts will be included as part of individual reports to accept formula and competitive grant funds.

KEY ISSUES AND IMPACTS

Process for Prioritization of Projects for the Formula Funds: The City must adhere to funding regulations and criteria in determining projects to be funded. These regulations and criteria differ by funding allocation. Under the direction of the Mayor and City Administrator, the City's interdepartmental planning committee on the stimulus is assessing priority projects with job retention and creation possibilities for Oakland residents as a major priority. Given the one-time nature of the ARRA funding, the City must also evaluate its ability to absorb any additional associated costs and sustain any new projects and programs. It is anticipated that the Council will participate in the prioritization process through the existing Council process.

List of Grants and Deadlines for Application: At this date, many funding agencies are still developing guidelines and deadlines for the ARRA competitive grants. Based upon the City's review process and information provided by City federal and state lobbyists, the City is considering submitting applications for the following grants, with the caveat that submission determination will be dependent upon meeting the regulatory requirements once issued:
