My name is Karen Smulevitz. I was born in Chicago, Illinois on March 14, 1945, and I will be 66 years old this year. In 1967 I moved to San Francisco and married Sheldon Smulevitz, and my daughter Amanda was born that year. In 1969 we relocated to Oakland and my son Daniel was born. I have lived in Oakland ever since, although separated from my husband. I have one grandchild, my daughter's son Jayden. Over the years I have held various jobs, but the closest I could come to claiming a career is to say I have always been a student of the world around us, trying to learn as much as possible about people and our environment.

I have been a bookkeeper, waitress, post office clerk and telephone operator. When my children were in preschool and elementary school, I was a stay-at-home mom who volunteered in their classrooms and tutored neighbors' children.

Going to school part-time. I completed two years of college and earned a certificate as a veterinary assistant, but went to work at the post office, as I was by then a single mom and needed the health benefits.

Later I drove taxicabs in Oakland for a woman-owned company which gave me the opportunity to learn the various neighborhoods in our city. We specialized in careful service to elderly passengers, and that is when I first became interested in the needs of senior citizens. That company, Taxi-Taxi, co-founded Van Go, an early wheelchair van service, before East Bay Paratransit was established. I have used this service myself, in times of ill health. When the company was sold, I worked as the office manager and dispatcher for the new owners..

In my last years of work, I was self-employed, chauffeuring older women and school children, and doing yard work and dog grooming.

In the 1990s my asthma became severe and I was hospitalized on a ventilator twice. Unable to work, I went on SSI. Being incapacitated ate away at me, so I joined the YMCA in order to improve my health. When I was well enough, I started walking, and walked right into United Seniors of Oakland and Alameda County, an organization that reflected my goals, and I am proud to say I am still a member. Today my asthma is under control, but in 2003 I was diagnosed with stomach cancer, had major surgery then and again in 2008. I thrnly believe that exercise and healthy living, pillars of United Seniors, enabled me to survive.

Also, I believe I am low income for a reason; it helps me empathize with vulnerable populations, and it has forced me to find happiness in the simple things. This stage of my life is second best only to raising my kids, and in many ways it's better. I have more time to volunteer and take part in pleasurable activities. Those to encourage other seniors to live well and participate in all that Oakland has to offer.

Besides being active in United Seniors, I am a vice-president of California Alliance of Retired Americans, and a board member of Oakland Parks Coalition. The creckside in Arroyo Viejo Park is my Adopt-a-Spot, where I am a park steward, and coordinate Earth Day events. I attend my NCPC as often as possible.

As a transit-dependent senior, I am avidly involved in transportation issues, often speaking before BART, MTC, and AC Transit boards. I follow Oakland's Bicycle

Pedestrian Advisory Council, belong to Walk Oakland Bike Oakland, Transform, and Urban Habitat's Transportation Justice Working Group. I believe it is important to speak for seniors whenever transit and pedestrian issues are discussed.
