RESOLUTION DECREASING ESTIMATED REVENUE AND OFFSETTING EXPENDITURES FROM THE 2010 RAIDERS TICKET SURCHARGE TO REFLECT ACTUAL REVENUES COLLECTED AND AUTHORIZING A TRANSFER OF \$136,665.54 WHICH IS THE ACTUAL REVENUE COLLECT FROM THE NON-DEPARTMENTAL CITYWIDE ACTIVITIES BUDGET TO THE OFFICE OF PARKS AND RECREATION BUDGET TO BENEFIT CITYWIDE YOUTH ACTIVITIES

WHEREAS, as part of the 1995 Master Agreement with the Oakland Raiders, a \$1.00 per ticket surcharge was created on all tickets sold for Raiders football games; and

**WHEREAS**, the proceeds from the Raiders Ticket Surcharge are distributed to the City, County and Raiders to benefit youth activities; and

WHEREAS, Oakland's Fiscal Year 2010-11 Adopted Budget includes an estimated revenue of \$160,000 and equal expenditures in Non-departmental City-wide Activities; now; and

WHEREAS, Raiders Ticket Surcharge actual revenue through the recently completed 2010 season amounts to \$136,665.54, therefore be it

**RESOLVED:** The estimated Raiders Surcharge revenue within the 2010-11 City of Oakland budget be decreased by \$23,334.46 in the General Purpose Fund (1010) to reflect actual revenues collected; and be it

**FURTHER RESOLVED:** The offsetting expenditures within the Non-departmental Citywide Activities be decreased by \$23,334.46 in the General Purpose Fund (1010); and be it

**FURTHER RESOLVED:** That the City Administrator or his designee is authorized to transfer \$136,665.54 from Non-departmental Citywide Activities to the Office of Parks and Recreation to benefit citywide youth activities, consistent with Council's desire to support youth recreation and sports programs in Oakland.
