President De La Fuente and Members of the City Council:

Pursuant to §401 of the Charter, and the action of the Council at its December 5, 2006, closed session, the City Attorney has prepared and requests your approval of a resolution authorizing compromise and settlement of the above-entitled action in the total sum of One Hundred and Ninety Thousand Dollars (\$190,000), payable in equal halves to Teresa Pham (identified in the action as "Jane Doe") and James B. Chanin, her attorney or record, and to Trang Pham (identified in the action as "Mary Roe"), and John I. Burris and Beth W. Mora, her attorneys of record.

The plaintiffs contend that they were subjected to unwarranted traffic stops due to their race/ethnicity and gender, and to inappropriate conduct of a sexual nature by then police officer Richard Valerga. This settlement is recommended as a compromise of this matter and to avoid a potentially adverse jury verdict.
