

INTRODUCED BY COUNCIL PRESIDENT LYNETTE GIBSON MCELHANEY

RESOLUTION RE-APPOINTING COUNCILMEMBER DAN KALB AS VOTING DELEGATE AND APPOINTING COUNCILMEMBER ABEL GUILLEN AS ALTERNATE VOTING DELEGATE TO REPRESENT THE CITY OF OAKLAND AT THE LEAGUE OF CALIFORNIA CITIES' 2015 GENERAL ASSEMBLY SCHEDULED TO BE HELD IN SAN JOSE, OCTOBER 2

WHEREAS, the City of Oakland is a Member City of the League of California Cities; and

WHEREAS, the Bylaws of the League of California Cities, Article V, Section 3 (a) state: "Designation. Each Member City may, with the approval of the city council, designate a city official as the city's designated voting delegate and, in the event that the designated voting delegate is unable to serve in that capacity, up to two alternate voting delegates"; and

WHEREAS, the City Council's Rules of Procedure (Resolution No. 82580 C.M.S.) state that "the President of the Council shall recommend appointments to regional and local boards and agencies, as appropriate, subject to confirmation by the Council"; and

WHEREAS, Council President wishes to appoint Councilmember Dan Kalb as the City of Oakland's Voting Delegate to the League of California Cities' 2015 General Assembly, and wishes to appoint Councilmember Abel Guillen as the City of Oakland's Alternate Voting Delegate to the League of California Cities' 2015 General Assembly to be held in San Jose on October 2, 2015; now, therefore be it

RESOLVED: That Councilmember Dan Kalb is hereby appointed the City of Oakland's Voting Delegate for the League of California Cities' 2015 General Assembly; and be it

FURTHER RESOLVED: That Councilmember Abel Guillen is hereby appointed the City of Oakland's Alternate Voting Delegate for the League of California Cities' 2015 General Assembly.
