

INTRODUCED BY COUNCILMEMBER LYNETTE GIBSON MCELHANEY

**RESOLUTION ACKNOWLEDGING THE 20<sup>TH</sup> ANNIVERSARY OF THE NEXT STEP LEARNING CENTER IN WEST OAKLAND AND RECOGNIZING THEIR TUTORING AND MENTORING PROGRAMS WHICH HAVE STRENGTHENED THOUSANDS OF OAKLAND FAMILIES UNDER THE LEADERSHIP OF SISTER CYNTHIA CANNING AND SISTER ROSEMARY DELANEY**

**WHEREAS**, the Next Step Learning Center was founded in 1994 by the Sisters of the Holy Names, to provide tutoring and educational assistance to members of the Oakland community, as well as addressing the high school drop out rate; and

**WHEREAS**, the Next Step Learning Center, located at 2222 Curtis Street in West Oakland, has been strengthening Oakland families and communities through intensive, personalized tutoring and mentoring in basic literacy, GED preparation, and transition to college and the workforce; and

**WHEREAS**, the mission of the Next Step Learning Center is to strengthen Oakland families and communities through intensive, personalized tutoring and other programs for reading, writing, and computation needed for urban life in the 21st century; and

**WHEREAS**, Next Step Learning Center believes in the resilience of the human spirit and in each person's ability to learn and change; and

**WHEREAS**, Next Step Learning Center provides a supportive environment which assists students to develop their self-confidence, strengthen their self-esteem, assume greater personal responsibility, and more fully reach their potential; and

**WHEREAS**, Next Step Learning Center has created a college-going culture that makes postsecondary education accessible to GED graduates; and

**WHEREAS**, Next Step Learning Center supports each person by providing a caring environment, bridges to the business and civic community, and a strong support and follow-up system; and

**WHEREAS**, over 5,000 Oakland residents have been served at The Next Step Learning Center with high participant satisfaction; and

**WHEREAS**, over 80 former high school dropouts have completed at least one semester of college since the inception of Next Step's college program in 2008; and

**WHEREAS**, over 700 former high school dropouts have achieved full GED certification, increased access to college and employment opportunities, and greater hope for the future; and

**WHEREAS**, over 300 Oakland and East Bay residents and employees have contributed thousands of hours to serve as one-on-one tutors or by providing technical support; and

**WHEREAS**, the effects of illiteracy are cyclical, passing from generation to generation unless there is effective intervention; now, therefore be it

**RESOLVED:** That the City of Oakland honors The Next Steps Learning Center on their 20<sup>th</sup> Anniversary; and be it

**FURTHER RESOLVED:** That the City of Oakland honors the leadership of Sister Cynthia Canning and Sister Rosemary Delaney in developing, leading, and sustaining The Next Step Learning Center with fervor, persistence and love for their students; and be it

**FURTHER RESOLVED:** That the City of Oakland recognizes the many volunteers and staff of the Next Step Learning Center who work diligently to ensure that each client receives educational supports to improve their lives and reach their potential.
