EXECUTIVE SUMMARY

This agenda report requests authorization for reimbursement of travel expenses for Councilmembers Kevin Jenkins and Treva Reid to attend the 53rd Congressional Black Caucus Foundation (CBCF) Annual Legislative Conference (ALC) in Washington, D.C., from September 11-15, 2024. The resolution authorizes the use of funds from the Council Contingency Fund to cover the travel expenses.

BACKGROUND / LEGISLATIVE HISTORY

The Annual Legislative Conference hosted by the Congressional Black Caucus Foundation is the premier public policy convening focused on issues impacting African Americans and the global Black community. The ALC provides a platform for thought leaders, legislators, and citizens to engage in discussions on critical issues, forge partnerships, and promote the social, economic, and political advancement of Black communities.

Councilmembers Jenkins and Reid will attend the conference to engage with policymakers, regulatory agencies, foundations, and think tanks to advocate for the City of Oakland's priorities and to gain insights into innovative solutions that can be applied locally. The event will include sessions on economic development, civil rights, public health, education, and more.
